CALL TO ORDER

Mr. LaHaye was not present. The department and Mr. LaHaye entered a stipulation in which Respondent admits to the allegations and agrees to pay the penalty of \$1,000.00 within 30-days after receipt of the Commissioner's acceptance. The stipulation was signed by all parties.

Mr. Hodge was not present. The department and Mr. Hodge entered a stipulation in which Respondent admits to the allegations and agrees to pay the penalty of \$1,000.00 with \$250.00 being suspended if paid within 30-days after receipt of the Commissioner's acceptance. The stipulation was signed by all parties.

LDAF REPORT:

Mr. Lyndon Leonards discussed staffing updates. Pesticide Registration Coordinator position is currently vacant. There are currently ten vacant inspector positions statewide.

Mr. Leonards updated the commission on the Unwanted Pesticide Program. The last pesticide pick-up disposal event was held on February 18, 2025. There were no additional events in 2025 and there are not any currently scheduled for 2026.

Mr. Leonards discussed registration updates for Section 18 requests.

Mr. Leonards discussed updated certification and training rules and regulations to meet new EPA certification and training plan requirements and currently working on updating the licensing program database updated to reflect the updated rules.

Mr. Leonards updated the commission on the new online certification testing system that was launched in November 2025.

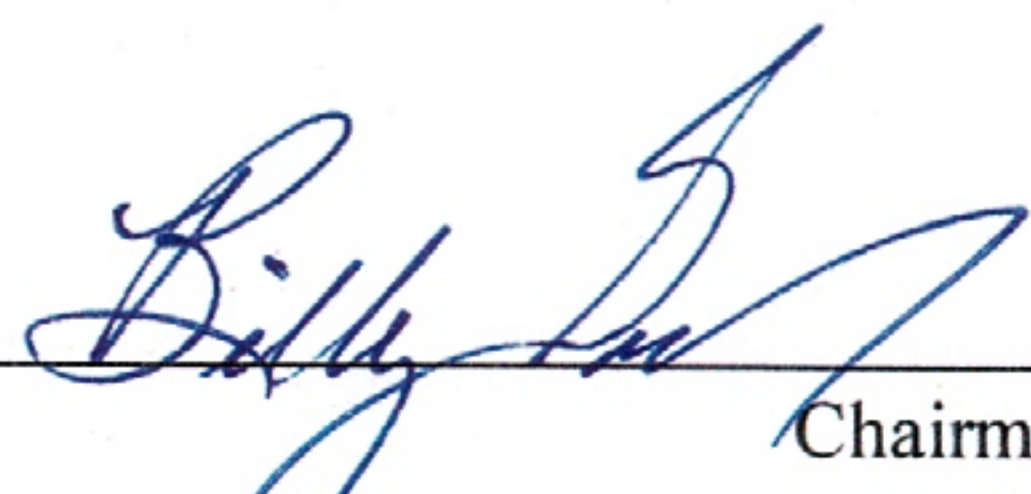
Mr. Leonards reported that LDAF investigated 346 pesticide complaints and 2,700 routine inspections during 2025.

PUBLIC COMMENTS

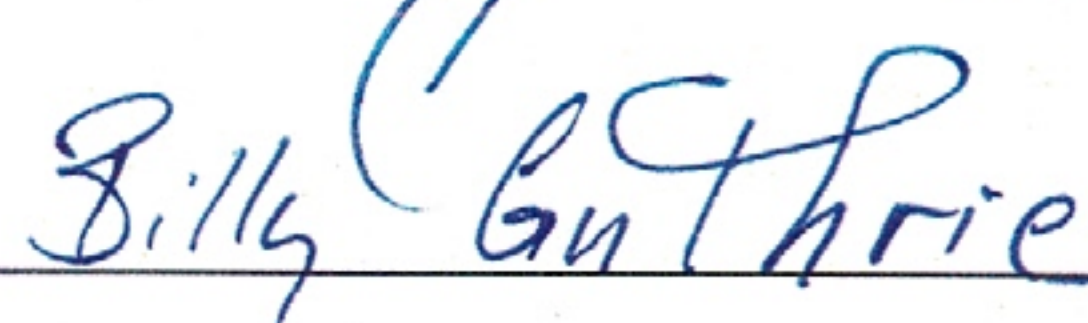
There were no public comments.
