## DEPARTMENT REPORTS

Mr. Simoneaux announced personal changes within Ag \& Environmental Sciences (AES). There have been 3 recent retirements in AES including Larry LeJeune and Butch Stegal.

Mr. Simoneaux reported that the complaints numbers are average. He also reported on the 2,4 -D resistant crops and that Dow has developed a different formulation for these resistant crops. Monsanto is working on a formulation also. These new products will certainly change the dynamics of what our inspectors do.

Mr. Simoneaux reported that our Inspectors continue to do a good job. The department has continued with the Inspector training. There are several other opportunities for our inspectors/staff to receive additional training through EPA Pert and Prep Courses.

Mr. Simoneaux reported that this year the Section 18's are up and that he had completed 10 so far this year.

David Fields announced that Kim Pope is the new Pesticide Safety Coordinator for LSU. He also discussed that WPS is a key component for EPA at this time. The department has hired a contractor for interpretation of telephonic interviews for WPS workers or handlers that may have left the state or the country. All of the AES inspectors are aware of this addition.

Mr. Fields said that LDAF in compliant with the new Container and Containment regulations.
