## VI. COMMISSIONER'S REPORT

- Commodity prices are moving in a positive direction.
- A number of different entities donated fuel during the 2021 hurricane season. An additional 15,000 gallon tank was installed at the Baton Rouge Headquarters to increase capacity. During the height of Hurricane Ida, LDAF was distributing 250,000 gallons of fuel per day.

## VII. OLD BUSINESS

Commissioner Strain informed the board of a motion he would like to have added to the agenda under Old Business. During the November 18, 2020, LAFA Board Meeting a motion was passed unanimously to allow LAFA to purchase four heavy duty scale test trucks at the cost of \$842,510.00 and lease them to Weights and Measures over 10 years.

Because of the pandemic, we are just now in the process of securing these four heavy duty scale test trucks and the test weights needed to "outfit" the trucks.

We will be asking to amend the cost and loan agreement to include another \$95,000 to purchase the test weights needed to outfit the trucks. The total loan would now be \$937,510.00 and would be lease to Weights and Measures over 10 years.

## A. Indian Creek

The lake has been drawn down and repairs are being made to the seawall. The Mardi Gras parade will be on February 26<sup>th</sup>, the Easter Egg Hunt on April 16<sup>th</sup>, and fireworks on July 4<sup>th</sup>. The newly constructed RV sites are continuously booked. Educational walking, hiking and biking trails are being constructed.

#### B. South Louisiana Rail Facility Loan

Michelle Ribera updated the board on the status of the South Louisiana Rail Facility (SLRF). Construction is currently 7% completed. Currently they are constructing foundation shafts. The slab is expected to be poured by March 1<sup>st</sup>, slipform by May 1<sup>st</sup>, with substantial completion by September 15<sup>th</sup>. Equipment installation is expected to begin by November 15<sup>th</sup>.

Commissioner Strain reminded the board that on February 18, 2021, the SLRF secured a \$2.4 million dollar loan through LAFA. The total project cost is over \$22 million. He has been in discussions to obtain federal dollars to place into LAFA's accounts to either payoff the loan or front the loan.

# C. Equipment Shed at LDAF – BRHQ

# i. Louisiana Seafood Processors Pandemic Response and Safety Program

Mrs. Ribera notified the board that LAFA's application for the USDA Seafood Processors Pandemic Response and Safety Block Grant Program was accepted. LAFA is awaiting final word that the grant has been awarded. This grant will provide \$4,229,669 for administrative cost and grants to seafood processors, at-sea processors and dealers for expenses related to COVID-19.

#### ii. Louisiana Farm and Timber Recovery Grant Program

Mrs. Ribera notified the board that the State of Louisiana's Office of Community Development (OCD) is working to secure funds from the

federal government to give to Louisiana producers effected by Hurricanes Laura and Delta. She expects LDAF/LAFA to administer this grant program. She hopes to receive notification of the program in 3-4 months.

#### E. Bee Grant

Commissioner Strain notified the board that there are currently 30 students participating in the program. The hives have been purchased and assembled, and the bees are in the process of being purchased. He has applied for an additional Specialty Crop Block Grant to further the Bee Grant.
