CALL TO ORDER

COMMISSIONER'S REPORT

- Mr. Simon updated the board on the status of the Lacassine Industrial Park/Porocel lease. He stated that LAFA will need to spend about \$75,000 to have the power connected at the mill.
- He informed the board that Groupo Gloria is about 60% complete with the dismantling of the mill.
- Mr. Simon notified the board LAFA received zero findings on this fiscal year's audit from the Louisiana Legislative Auditor.
- Ms. Tullier notified the board that it was time to complete their yearly ethics training and Tier 2.1 Financial Disclosure form.
