Steven Grissom gave an update on some of the economic activity occurring in Louisiana.

- ❖ Shintech − \$1.4 billion expansion in Iberville Parish
- Estimated 100 new direct jobs
- Retaining 335 existing jobs
- 350 contract workers
- ❖ Sasol announced a groundbreaking in the Lake Charles area of a \$8.1 billion ethane cracker complex.
  - 500 new direct jobs
  - 2400 indirect jobs
  - Expectations for 5,000 construction jobs

Both are associated with ethane cracker projects. Sasol is investing in 6 chemical plants that will utilize the ethane produced and convert it into a broad range of chemicals used for products such as detergents, synthetic fibers, fragrances, paints, etc.

- ❖ CenturyLink completed a new technology center of excellence. A 300,000 sq. ft. facility.
  - 800 jobs
  - 1200 new indirect jobs in the Monroe area
- ❖ IBM announced a 400 job application development innovation center in Monroe with 400 indirect jobs.

The Department has a great pipeline of opportunities for companies looking to cross the state and the Department anticipates more investments in the coming months ahead.
