Minutes of the Meeting of the Louisiana State Board of Social Work Examiners June 10, 2011

Emily Efferson, Administrator, and Regina Breaux, Administrative Assistant, were present for the entire meeting. Other individuals present for a portion of the meeting were Carmen Weisner and Linda Kelly Woodruff.

Hope Himel-Benson, LCSW, conducted roll call. Board members present included Evelyn Jenkins, LCSW, John McBride, LCSW, Hope Himel-Benson, LCSW, Michael Hickerson, RSW, Lisa Lipsey, LCSW, and Naaman Stewart, LMSW.

PUBLIC COMMENTS

Carmen Weisner, Executive Director of NASW-LA Chapter, briefly discussed the bill that Senator Mount introduced to combine the LPC board and Psychology board. Ms. Weisner stated that Senator Mount assured NASW that social workers would not be included in this bill.

AGENDA

PRESENTATION OF CONSENT AGREEMENT AND ORDER

Compliance Hearing for Derick Dauphin, MSW

Mr. Dauphin requested a Compliance Hearing to appeal the board's decision to deny his RSW application on April 29, 2011. His application was denied because he did not indicate on his application that he had any state or federal charges. However, his criminal background check documented charges. Mr. Dauphin testified that two of the arrest charges were not accepted, and that one of the charges has been expunged. Mr. Dauphin was represented by attorney, Tony Dooley. Mr. Dooley explained to the board that expungement is explained to the lay person by the court that once the charges have been expunged it is as if the charges never occurred.

Compliance Hearing for Ursula Chew

Ms. Chew requested a Compliance Hearing to appeal the board's decision to deny her RSW application on April 29, 2011. Her application was denied because she did not indicate on her application that she had any state or federal charges. However, her criminal background check documented charges. Ms. Chew testified that she was arrested, but never charged. She stated that she hired an attorney to have her record expunged. The charge dated June 2, 2003 should have had the date June 2, 2006. The 2006 date is currently in the process of being expunged.

Compliance Hearing for Michael Breaux, LMSW

Mr. Breaux requested a Compliance Hearing to appeal the board's decision to deny his LCSW application on April 29, 2011. His application was denied because he did not indicate on his application that he had any state or federal charges. However, his criminal background check documented charges. Mr. Breaux testified that he was arrested in 1993 and charged with peeping tom. The DA declined to prosecute. Mr. Breaux stated that because the DA did not follow through with the case, he believed that it would not be a part of his record. He further stated that this has not been an issue with his employers, and has had to have a criminal background check completed to coach little league football. He stated that his life has changed since he was in college. He is now married with three children and heads the Children's Ministry at his church.

Compliance Hearing for Sarah Coker, MSW

Ms. Coker requested a Compliance Hearing to appeal the board's decision to her application for the LMSW on April 29, 2011. Her application was denied because of her affirmative answers on her application relative to having been charged with violation of any state or federal, civil or criminal law and have been a participant in an alcohol or drug treatment or rehabilitation program. Ms. Coker testified that she completed an 8 hour class in Boca Raton, and completed a misdemeanor intervention program. She received four months probation with monthly UA's. Because of her compliance, the charges were dismissed. Ms. Coker did present the board with evidence that she completed the above mentioned requirements.

Ms. Williams described a situation where she wants to nominate a client's brother for a local television stations "Hand It On" series. Members of the board advised Ms. Williams that the client should be informed of the proposal. If the client agrees to the nomination, the nomination should be submitted by Ms. Williams' employing agency.

Members of the board reviewed correspondence submitted by Constance Konikoff, LCSW. Ms. Konikoff presented the board with a situation where a psychiatrist asked Ms. Konikoff if the LABSWE supports social workers making medicine recommendations to the medical doctors as to which medicine to prescribe to their mutual patient. Members of the board agreed that this is outside of the scope of practice of a social worker. Ms. Konikoff was referred to 2703(15)(b), of the Louisiana Social Work Practice Act.

Members of the board reviewed correspondence submitted by Renee Mainous, LCSW. Ms. Mainous asked if private practitioners in the state of Louisiana can administer certain psychological tests once they have been certified to do so. Ms. Mainous was advised that the Louisiana Social Work Practice Act prohibits a social worker to administer or interpret psychological tests. Ms. Mainous was referred to 2703(15)(b), of the Louisiana Social Work Practice Act.

Motion was made by Evelyn Jenkins, seconded by Michael Hickerson and unanimously carried, to allow Lynne Robinson, LCSW, to complete all of her continuing education hours via distance learning. These hours must be completed on or before June 30, 2011. Ms. Robinson submitted a request along with medical documentation supporting her request to complete her hours via distance learning.

Motion was made by Michael Hickerson, seconded by Evelyn Jenkins and unanimously carried, to allow **Susan McCormick, LCSW**, to complete all of her continuing education hours via distance learning.
