Flora Cooper, LCSW – requesting approval of 2019 Board Orientation Workshop for BACS

Jennifer LaCarriere, LMSW - question regarding scope of practice for an LMSW **Motion** was made by Hyacinth McKee, seconded by Jamie Barney and unanimously carried, to deny Jennifer LaCarriere's request to provide alternative dispute resolution services or services as a parenting coordinator on an independent contractual basis. Gena Lewis and Stephanie Davis made a public comment.

Lisa Mansfield, LMSW - request to remove disciplinary flag **Motion** was made by Jamie Barney, seconded by Carla Moore and unanimously carried, to approve the removal of the disciplinary flag from the website for Lisa Mansfield.

Victoria Judge made a public comment.

Suzzette Addison - question regarding minor client and information provided by parent Board members advised Suzzette Addison that the situation described is not a regulatory board issue. It is hypothetical and has too many unknowns. Board members recommended that she seek legal counsel.

Elizabeth Black, LCSW - question relative to providing services through employment with an agency and contractual services with the agency Board members advised that she should submit her question to the Louisiana Board of Ethics.

Katherine Hebert, LCSW-BACS - question relative to providing BACS supervision with former client

Board members advised that she must determine if providing supervision is in the best interest of the client. The Board recommended she review Rule 113(B)(6). Alexis Fabre provided a public comment.

Tamar Stark, LMSW - requesting approval of job description for BACS supervision **Motion** was made by Hyacinth McKee, seconded by Bora Sunseri and unanimously carried, to deny the position of Senior Academic and Career Advisor as eligible for working towards the requirements for LCSW.

Katelyn Powell, LCSW – requesting removal of disciplinary action **Motion** was made by Hyacinth McKee, seconded by Carla Moore and unanimously carried, to approve the removal of the disciplinary flag from the website for Katelyn Powell.

Jill Murray, PhD, LCSW-BACS - question regarding an LPC that also holds the LMSW The LPC who is also a LMSW is required to follow the requirements of the Louisiana Social Work Practice Act and the Rules, Standards and Procedures in order to become a LCSW, which means that the individual is not authorized to provide services independently through a contract.

Barbara Dunn, C&P Specialist - question regarding a social worker ordering lab work The Board advised that ordering lab work is not within a social worker's scope of practice.

Vanessa Rubin, LPC, RSW - requesting removal of disciplinary action **Motion** was made by Hyacinth McKee, seconded by Ada Nelson and unanimously carried, to approve the removal of the disciplinary flag from the website for Vanessa Rubin.

Gina Rossi advised that social workers with disciplinary action are not eligible for the social work compact.

Jerrelda Sanders asked how to advocate to change the national databank to allow removal of disciplinary action.
