Both reported briefly on the content and benefits of the training for adults. They recommended that all members attend the training as opportunity is presented. There was discussion regarding the community representation at the meeting and the interest expressed by the Louisiana State Police and the Sheriff of EBR Parish to have their officers attend the training.</li> <li>Mental Health First Aid-Youth: The single day training will be offered on 8/21/13. Dr. Kasofsky will attend the training. Four slots are designated for CAHSD Board members. Lunch will be paid for.</li> <li>CIT Training Rescheduled: October 7-11th</li> <li>Fall 2013 Staff Development &amp; Community Training Series: There was brief discussion regarding this training opportunity. It was noted that training classes are now held at CAHSD at the Government Street location and not at the Louisiana State Police building.</li> <li>Bullying Prevention Handout: An overview was provided of the bullying handout developed by Vivian Gettys. She also wrote an article on bullying which was published recently in The Advocate. Additional information on bullying is available upon request.</li> <li>Client Orientation Handbook: A copy of the Client Orientation Handbook was distributed to each Board member. The handbook was developed according to CARF standards.</li> </ul>	
Primary Care Integration	Dr. Kasofsky	<ul> <li>On-site Services: Dr. Kasofsky reported that a primary care clinic near the Baton Rouge General is interested in receiving referrals from CAHSD. The clinic has offered to house a nurse practitioner onsite at CAHSD every other week for one afternoon to see indigent clients. The clinic will be able to receive referrals of non-indigent clients who are not already connected with a provider with either Medicaid, Medicare or are privately insured. The clinic physician is a chronic disease specialist which will work well with CAHSD clients.</li> <li>Community Health Worker Initiative in Pointe Coupee: V. Gettys and Dr. Kasofsky recently met with Chad Olinde, CEO, Pointe Coupee General Hospital. He was told that while the community health workers have been focusing on diabetes and hypertension that they wanted to add a mental health and addictive</li> </ul>

A few mental health and substance use questions will be added to the screening survey the community health workers use in the homes.  • Heat Safety: There was discussion regarding the heat and how clients taking certain atypical medications may have body temperature regulation issues. A flyer with heat information has been developed and can be obtained from V. Gettys.	
BH Crisis Services Development	Dr. Kasofsky	<ul> <li>In a recent meeting with Craig Coenson, M.D., Magellan President, it was determined that a rapid stabilization program similar to the MHERE is needed in this community, not a residential program. There is discussion with a private provider to provide these services and the goal is to have up to 20 beds available for this purpose within 6 months.</li> <li>Three receiving centers are needed across the State in the following areas: Baton Rouge, New Orleans, and Lafayette. Services will be provided by a private provider and Magellan will reimburse for those services. The reimbursement rate would be approximately \$358. CAHSD will enter into a contract in which a certain number of dollars would be paid for a designated number of indigent beds. The hospitals may also want to reserve a few beds. There will be further meetings to discuss the referral process. CEC's, PEC's, and OPC's may be able to go directly there with a nurse practitioner to access their physical health.</li> <li>Dr. Kasofsky recently met with representatives from Lane and Ochsner Hospitals. These facilities are not being inundated with behavioral health clients. They have agreed to report the number of patients seen in a behavioral health crisis from last January through October 2013</li> </ul>	
OLOL Psychiatry Residency	Dr. Kasofsky	<ul> <li>Kathleen Crapanzano, MD, Residency Program Director at OLOL, contacted CAHSD to find out if there was interest in having six, second year residents work at CARP, CAHSD's inpatient drug treatment program.</li> <li>Dr. Linszky, CARP physician and Dr. Udofa, CAHSD Medical Director are providing oversight to those residents now working at CARP and all is going well.</li> </ul>

Mental Health Court Training for Judges	Dr. Kasofsky	<ul> <li>The Council of State Governments, a Federally funded program that nationally assists states to implement Mental Health Courts, will provide an assessment free of charge to determine the type of training needed by the judges to establish the mental health courts.</li> <li>The Judges, Warden, and Police Chief are very excited about the program. They want repeat offenders to get into treatment rather than go back to jail</li> <li>The program hasn't yet started but preliminary discussion is in process.</li> <li>A proposal will be received from the Council of State Governments who will provide technical assistance to local Judges.</li> </ul>	
Update on 2014 budget	Carol Nacoste	• C. Nacoste provided an overview of the budget as outlined on the budget handout in the Board packet. She reviewed the adjustments made to the budget during the development process. Reductions are indicated in red, additions are indicated in black. There was discussion of zero based budgeting. There was discussion of salary reductions, contract reductions and interagency transfers. She explained (1) OBH Reduction (TANF) ECSS and OCS IAT (2) OCDD Reduction (LINCCA Transfer) Cash Subsidy & Family Support IAT, (3) OBH Substance Abuse Block Grant Reduction (Cut) IAT and (4) Annualization of mid-year cut (10 positions). Total of cuts that impacted services to clients and individuals with Developmental Disabilities is \$2,020,962. She explained the reductions that do not have an impact on clinical services. The total of these reductions are \$374,970. Total funding reductions FY2013 to FY2014 is \$2,395,932. CAHSD's current budget is \$29,827,102.	
Self-Generated Revenue (SGA)	Carol Nacoste	• C. Nacoste reviewed the SGR Fiscal year close out report as of June 2013. Revenue collected is \$2,202,097.04 of the \$4,254,241.00 budgeted to collect. It is unlikely that CAHSD would ever collect the budgeted amount no matter how many clients because the budgeted numbers are inflated. Part of the problem with the projected SGA budgeted numbers is that they are based on 30% of all clients with addiction needs being Medicaid

		eligible and it is really about 3%. \$2,202,097.04 is the amount in the bank at the close of the June 30 bank statement. The projected Surplus/Deficit is \$2,039,878.94. This is how far CAHSD is from collecting to Budget. Outstanding collections were reviewed line by line. Different types of denied claims were explained. Collections have increased to 60% due to the hard work of CAHSD billing staff.	
Electronic Health Record, Social Services Counselors	Dr. Kasofsky	<ul> <li>Electronic Health Record: Since CAHSD has not been able to utilize Clinical Advisor (CA) to process billing, CAHSD has made a decision to purchase a product called ICANOTES designed specifically for outpatient mental/behavioral health. Five other Districts have signed on to purchase this product. CAHSD has organized a team within CAHSD and a team that includes staff across the six Districts. When customization of a form is needed (i.e. to collect specific data required for block grant reporting) the cost will be shared across the six Districts. CA is not being used for scheduling in the largest CAHSD clinic but is being used in the smaller clinics. It works in communities that don't have so many different providers working with the same clients. The goal is to have ICANOTES implemented in October 2013.</li> <li>Social Services Counselors: Four social services counselors have been hired as a result of the recent focus group with CAHSD top performing social workers and the result of a survey of CAHSD clinicians. The clinicians reported that they most needed an electronic health record that did not waste a lot of their time. It was also identified that they needed someone with a background in human services, but not necessarily a clinician, to help them with obtaining prior authorizations and other requirements of managed care companies. Social services counselors will be allocated as follows: (1) one will be shared between Addictions, CABH &amp; CBHS (2) one full-time with MH CABH (3) one at MDMHC and (4) one at GMHC.</li> <li>LCSW Social Worker: A LCSW social worker will be added to the CAHSD satellite team. The team leader will have responsibility to go out into the parishes, getting known, making sure that people and physicians in the community know where we</li> </ul>
