1. Overview of Louisiana Child Death Review Report, 2013-2015

Lydia Plante, Mortality Epidemiologist for LDH-OPH-Bureau of Family Health, presented major findings from the Louisiana Child Death Review report produced earlier this year. The team recommended a presentations be scheduled with the following organizations to present the report's findings: Legislative Health and Welfare Committee, Louisiana's chapter of the American Academy of Pediatrics, Human Services Districts, and parenting classes.

2. Drowning Subcommittee

3. Safe Sleep Subcommittee

Laurel Kitto has agreed to chair the Safe Sleep Subcommittee. The committee is currently focused on responding to HCR 58 that requests a report be produced by the Bureau of Family Health, State Child Death Review, and Department of Child and Family Services to evaluate the desirability and efficacy of a statewide "baby box" program as a means of reducing infant mortality. The report is due to legislature early January. Future priorities of the subcommittee include examining methods for provider safe sleep education and identifying ways to improve teaching strategies employed by providers.

4. Child Death Investigation Recommendations

State Child Death Review is required to establish the child death investigation protocol for Louisiana per R.S. 40:2019. A 2016 subcommittee of State Child Death Review produced recommendations that were presented this month at the Louisiana Homicide Investigators Association meeting. Attendees suggested the recommendations be further disseminated by making them available to fire services, the District Attorneys' association, and the Coroner's Association. See attached.


