Meetings Post-COVID Discussion:

- Louisiana Department of Health will be back in the offices by August 9th.
- Pre-Covid-19, meetings were done in Baton Rouge.
- The group shows a preference towards a hybrid meeting layout. 1-2 in person meetings per year would be in person but zoom will always be available.
- Pam Cart suggested the use of the LOPA facility in Covington for ease of IT availability.
- BFH team will also look into other places in Baton Rouge to hold the meeting (Fire Marshal's, DOE, etc.)
- Panel may experiment with case sending ahead of time vs presenting in meeting instead.

Firearm Safe Storage Campaign Messaging and Funding Needs:

- BeSMART has been meeting with BFH on materials testing and development.
- BeSMART is working on a mockup of the pamphlet and will get that to BFH by the week of June 30th. BFH will resume a quick round of audience testing on this new content.

- Materials will be distributed in gun ranges, gun shops, training facilities, and pediatrician offices as well as other places including law enforcement training academy and public health units as suggestions
- Contact Jia Benno if you have suggestions for indoor/outdoor distribution sites and contacts, funding sources for printing, want to participate in materials testing, or are interested in being a spokesperson about the campaign on behalf of State CDR.
- Pam Cart and Chief Edwards requested a list of need and cost.
- LOPA has a podcast that can be used as a speaking platform for firearm safe storage.
- Sheriff Webre and Val Martinez of Lafourche Parish Sheriff's office may be able to help.

POLICE TRAINING RESOURCES

CHILD DEATH INVESTIGATIONS: A-Z AND EVERYTHING IN BETWEEN

This course offers a comprehensive view into the deaths of children that law enforcement encounters both as patrol officers and investigators. The first day addresses all manners and mechanisms of death. The perspective of the materials is that of the pathologist, and how they come to the final determinations of cause and manner based on the overall investigation into a death. The role of law enforcement and other outside agencies is critical in that determination. Participants will learn how crucial the local investigation into circumstances and confirmation of particular details, in conjunction with the autopsy, is to that final determination.

The second day covers many of the logistical aspects of death investigation, to include court issues, scene considerations, case studies, and working with outside agencies. We welcome detectives, patrol, prosecutors, medical examiners/coroners, child protection professionals, and other related disciplines to attend. There is a strong emphasis on interagency collaboration in this course so any disciplines directly involved in these types of cases are encouraged to attend.
