- II. Public Comment
 - a. Time was allotted for public comment. No comments were made.

 - b. Lisa Freeman shared that the Highway Safety Commission of the Department of Public Safety and Corrections had obtained funding for Pediatric Vehicular heat stroke prevention. The press conference for the awareness campaign kickoff will be held on May 1, 2024, at 9:00 am.
 - c. Robyn Thomas shared that OBH is working to expand crisis services (Mobile Crisis Response and Community Brief Crisis Support) to Medicaid members under the age of 21.
- V. CDR 2019 2021 Annual Report Presentation
 - a. Lauren Dyer presented the 2019-2021 Annual Report, summarizing trends and data for the top causes and risk factors of child death.
 - b. The Panel would like to explore CDR reports from other states to determine what they are doing differently that could be implemented in Louisiana.

 - a. Panel members discussed potential focus areas for 2024. The Panel would like to focus on how the data and recommendations discussed during panel meetings to the correct audiences.
 - b. Members suggested presenting CDR data/ recommendations to the Children's Cabinet Advisory Board.
