V. Old Business / Announcements

VI. Implementation Update – Glenn Ledet, Jr., CPRA (video 00:03:50)

Mr. Ledet updated the Board on the latest progress of various projects around the coast. CPRA has 106 active projects with 38 are in construction, 64 in engineering and design, with 4 more in the planning stage. Of the projects now being constructed 15 are hurricane protection projects and 9 are creating marsh. Mr. Ledet updated on changes from last month:

- Lower Lafitte Tidal Protection Completed
- Rockefeller Shoreline Protection Restore Parish Matching Completed
- Port Fourchon Shoreline Protection Bids were opened on 03/06/2025



- Breton Landbridge Marsh Creation (West), River Aux Chenes To Grand Lake Headed to Construction (Bid)
- MTG Improvements NLLD To Be Bid in the Next 6 Months
- St. Catherine Island Marsh Creation & Shoreline Protection To Be Bid in the Next 6 Months

Mr. Ledet also provided updates on a few Shorelines Protection & Restoration projects: Rockefeller Shoreline Stabilization: This project will be constructed along the Rockefeller Wildlife Refuge and Gulf of Mexico shoreline. This project involves the continuation of breakwater structures along the Gulf of Mexico shoreline in Cameron Parish immediately westward of the ME-0037 project, expanding shoreline protection of the Rockefeller National Wildlife Refuge. The project was a huge collaboration of funding between CPRA, Cameron Parish, Calcasieu Parish, and DENR. Labranche Marsh Creation & Shoreline Protection: This project involves designing and constructing ~13,000 of rock breakwaters along the last remaining unprotected segment of St. Charles Parish's Lake Pontchartrain shoreline. Construction began on 1/15/25. The current work includes -Limited rock has been placed. The primary activity has been the first 1,000' of geogrid with rock placed to pin it down. The major construction of the breakwaters will begin in 2 weeks with anticipated completion: Fall 2025. Funding breakdown for this project: (GOMESA: \$6M); (2022 Surplus: \$5,699,481.22); (2021 Surplus: \$12M); and (20220 Surplus: \$988.000). Mr. Ledet also provided a Restoration Update: Chandeleur Island Restoration Project: CPRA awarded the Pre-Construction Phase contract to Weeks Marine, Inc. The scope of this contract includes participation in the design process, which involves providing constructability input, cost estimates, and construction schedules for the preliminary and final design phases. Since 2018, Weeks Marine has constructed nearly 150 miles of beaches and restored over 12,000 acres of marsh. He also highlighted a partner project: Fritchie Marsh-New Orleans to Venice (NOV) Mitigation: The project involves ~295 acres of marsh creation to mitigate for 153.8 acres of intermediate, brackish, and saline marsh impacts associated with NOV NFL construction. Funding for construction is 100% USACE; CPRA is Non-Federal Sponsor. In closing, Mr. Ledet highlighted additional CPRA Updates: Love the Boot Week CPRA staff collected approximately14 bags of trash as part of Love the Boot Week, Louisiana's largest litter cleanup and beautification effort organized by Keep Louisiana Beautiful and supported by the Office of the Lieutenant Governor. In March, the ribbon cutting ceremony for Port Wonder in Lake Charles took place, marking the final step before the facility opens to the public. On March 26th, The Commission was updated on ongoing progress at CPRA and the FY26 Annual Plan, coastal job industry trends, efforts of the Resilience Task Force, and fisheries resilience projects underway at LDWF. He announced Coastal Day will be held on May 12th and the State of the Coast will be held May 20-22, 2025.



VII. Update on DRIVE Initiative – Clay Parker, CPRA (video:0:28:17)

Mr. Parker provided an update on the DRIVE Initiative starting with Background: Reorganization under Executive Order 2024 JML-13. The objective is to enhance operational efficiency, improve interagency coordination, and strengthen resilience. He stated that the purpose of feedback was to engage stakeholders with transparency. Mr. Parker also explained the phase five goals, with the primary goals being Legal Framework alignment: clear task assignments and budget structure, and long erm continuity. There were three areas of focus: Laws, People and Budget (all with outcomes that enhanced improved operational efficiency and enhanced legal compliance). Mr. Parker also provided updates on the Natural Resources Commission which will consist of Statewide Flood Protection, LED, DEQ, PSC Commission, LDWF, DENR, and LDR (will be staffed by the Office of Natural Resources Commission and will meet quarterly). In closing, he provided information on each office under the DENR reorganization chart.



VIII. FY 2026 Annual Plan – Glenn Ledet Jr. & Brian Lezina, CPRA (video:0:50:14)

The total projected expenditures FY 2026 by project phase approximately \$1.98 Billion investment in our coast. Of those funds, \$1.57B is allocated for construction, the projects will support 13,154 direct jobs with \$773 Million in labor income; 21 dredging projects slated for construction totaling 71.5M cubic yards of sediment to create or nourish more than 16,017 acres. Mr. Ledet also updated on the Southwest Region (46 Projects in OM&M): 21 active projects: 12 in Construction, and 9 in E&D. In the South-Central Region there are 41 active projects: 18 in construction, 20 in E&D, and 3 in planning. The Southeast Region has 84 active projects: 47 are in construction, 33 in E&D, and 4 are in planning. Mr. Lezina provided a brief update on the Atchafalaya Annual Plan. He stated that the goal is to manage the use of Atchafalaya River system sediments and water to maximize ecosystem functions and support continued human uses.
