#### ۷. **Old Business/Announcements**

• Chuck Perrodin Memorial Video (Former CPRA Communications Officer)



/I. CPRA Implementation Update — Bren Haase, CPRA (video: 00:00:00) Mr. Haase presented to the board that there are 100 active projects. 40 of them are in construction, 57 are in E&D, with 3 more in the planning stage. Of the projects now being constructed, 26 are hurricane protection projects and 39 are creating marsh. Mr. Haase updated the board on the following projects: Grand Cheniere Ridge and Marsh Creation (Plaquemines Parish) This project will create to date creating 340+ acres of marsh, this projected is funded by \$65 Million (NRDA) Natural Resource Damage Assessment; Lake Borgne Marsh Creation: The project is located in St. Bernard Parish. It's about a \$ 114.6 million project coming from NRDA funds which will restore approximately 2,769 acres of marsh; Mr. Haase closed by announcing dates for the upcoming Atchafalaya NERR Scoping meetings in mid-April. He also recognized one of CPRA's own Krista Jankowski, PhD for receiving the Tulane University School of Science and Engineering 2023 Outstanding Service Young Alumna Award.

 VII. 2023 Coastal Master Plan Update – Bren Haase and Stuart Brown, CPRA (video:00:00:00) Mr. Haase and Mr. Brown briefed the members on the 2023 Coastal Master Plan highlighting the key factors of the plan:
• Prioritization effort

•How can the state spend its money most cost-effectively over the next 50 years to reduce storm surgebased flood risk and restore and maintain coastal wetlands?

- Developed through a process that ensures adaptive management
- •Required by law to be updated every 6 years
- •Built on world class science and engineering
- •Advances a comprehensive and integrated approach to restoration and risk reduction
- Incorporates extensive public input and review

•Illustrates how people and communities will experience a changing coast to allow preparation and adaptation into the future.

The Master Plan Process (Projects, Modeling and Prioritization (Planning Tool)). The plan includes 65 Restoration Projects, 12 Structural Risk Reduction Projects, and \$11B for Nonstructural Risk Reduction. The Restoration projects will include \$2.9 Billion new\* diversions, landbridge projects, over \$19B in dredging projects and \$2.5B in Programmatic (Barrier Islands, small-scale hydrologic restoration, oyster reefs, shoreline protection). Mr. Brown also stated that under the Risk Reduction Projects in the plan, the Structural Risk Reduction includes, 12 projects and \$14B. The nonstructural Risk Reduction has \$11.2B of The Master plan budget is allocated toward nonstructural risk reduction measures, such as elevations, floodproofing, and voluntary acquisition. In closing, Mr. Haase echoed Chairman Kline's Master Plan statement noting: This level of investment could mean that in 50 years, under the lower environmental scenario, Louisiana has less flood risk from hurricanes and tropical storms than we do today.

VIII. FY 2024 Annual Plan – Bren Haase,CPRA (video: 00:00:00) Mr.Haase provided the board with an overview of the Final version of the FY 2024 Annual Plan. This plan is a \$1.62 Billion Investment in our Coast, with \$1.3 Billion being allocated for construction. 21 dredging projects slated for construction totaling 77.3 million cubic yards of sediment to create or nourish more than 14,578 acres. In the Southwest Region (21 Active Projects: 9 in Construction, 12 in E&D); South Central Region (48 Active projects: 24 in construction, 21 in E&D, 3 in Planning; Southeast Region (78 Active Projects: 50 in Construction, 25 in E&D, 3 in planning); Southeast Region (78 Active Projects: 50 in Construction, 25 in E&D, 3 in Planning).

- - Federal Update Neal McMillin, Governor's Office (video: 0:0:00:00) Mr. McMillin presented to the board updates on the Revenue Sharing Momentum. He highlighted the last Shores Fly-In:

Mr. McMillin shared that the Lower Energy Costs Act Passed the House (H.R.1 Included Breeze Act) The Breeze Act- Policies & Value:

- Louisiana is forecasted to gain \$3.1 billion over 10 years (FY23 FY32) from removing the GOMESA cap and increasing the GOMESA percentage to 50 percent.
- Shared revenues would also increase by being exempted from budget sequestration, which routinely diminishes GOMESA revenues by around 6 percent.
- If BREEZE is passed ahead of this summer's Gulf of Mexico offshore wind lease sale, then Louisiana could receive 50 percent of the proceeds, alongside Texas.

# **RISEE Act Update:**

'PAYFOR' CHALLENGE EMERGES IN SENATE

The RISEE Act sponsors reintroduced the exact version that passed unanimously through Senate Energy & Natural Resources Committee in 2022, hoping to streamline passage through the committee this Congress.

Unfortunately, Chairman Manchin has required a 'payfor' to fully offset the \$11.6 billion budget score for RISEE Act before advancing it through the Committee.

Negotiators would like to avoid committing to this at this juncture, given the competitive nature of offsets. May 3rdis the first markup opportunity, but the RISEE Act is currently off the agenda.
