- **B. Executive Director's Report N. DeDual:** Reiterated the purpose, authority and responsibility of LCD staff and board for coordination, facilitation and/or provision of accessibility services; provided the balance of the LCD Trust Fund as of October 2012, as well as the revenue and interest collected to date in SFY 2013; and the balance of the Trust Fund after SFY 13 budget; and that LCD has requested \$2.2 million from state-general funds for SFY 14 budget. Also, provided itemization and totals of SFY 13 payments for administration; telecommunication equipment; hearing aids; and payments to contractors for professional services including equipment distribution; hearing aid administration; ASL interpreting services; and SSP services. Provided the SFY 2012 performance reports of consumers served statewide. Provided the SFY 2013 report for state-interpreter certification, the process by which interpreters provide notice of their national certification and pay a \$26 money order to DMV for a background check which certifies them as a state interpreter for four years. Provided updated resources for consumers with hearing loss; LCD RSCs contact info; and meetings/presentations by LCD staff; and ADA info.
- C. Relay Administration Board Report: T. Covello/N. DeDual shared news from RAB meeting and update on Stephen Leon and Hilda Jarreau vs. LPSC/RAB class-action lawsuit in which plaintiffs contend they represent the class of persons who paid \$.11/month fee on landline phone bill ten years ago; and contend LPSC/RAB did not have authority to apply the fee to provide for statewide public relay services.

D. Commissioner Reports:

LRID – L. Knowles – In September, LRID hosted their annual conference and elected Gary Morgan as President. Mr. Morgan has designated Ms. Knowles as his LRID designee to the LCD. Ms. Knowles thanks outgoing LRID officers. On Oct. 1st, a transition meeting was held. The Region IV representative will be in attendance at the regional RID conference. LRID wants to include interpreter training information to the statewide resources list: DAC –LA (online ASL) and Delgado Community College (associate degree). LRID is also preparing training for interpreters; and requests interested persons contact them through the LRID website at http://www.lrid.org

Parent – D. Hardy – Her daughter's class recently read 'Rosina', a story about a young deaf girl; and an interpreter signed the story to introduce the class to ASL and Deaf culture.

LRS/VR - G. Montgomery - A vacancy for the Rehab Counselor for Deaf/HH job in Shreveport is now posted. All other RCD jobs are filled with well-qualified, experienced personnel. LRS staff are conducting presentations to disability support staff at colleges and vo-techs to educate about responsibilities for interpreting services. LRS may provide ASL interpreting services at colleges or vo-techs for a limited duration; but also assists their staff in development and/or coordination of support services and/or systems for communication accessibility.
