F. REPORTS

1. Chair of the Board Report

Chair Hardy provided the following report:

- ❖ On November 10th, LCTCS signed a historic agreement with the Southern University System that provides all Phi Theta Kappa (PTK) graduates with guaranteed admission to Southern University Baton Rouge (SUBR) and Southern University New Orleans (SUNO). In addition to guaranteed admissions, all PTK graduates will receive a scholarship of \$750 per semester, which will be applied after financial aid. Last year, over 740 LCTCS students transferred to either Southern University Baton Rouge or Southern University New Orleans.
- ❖ The September 14, 2016 meeting minutes have been revised to update a clerical error that incorrectly identified the Delgado Culinary Arts program as having been ranked 50th nationally instead of the correct ranking of 15th.
- Congratulate the colleges who had graduating classes this fall. Thank you to the Board members who were able to attend the ceremonies.

❖ The agenda reflects a period of Public Comment. Pursuant to Act 511 signed into law June 16, 2016, the Board is providing the opportunity for the public to offer input and comment on the Act 391 and Act 360 projects that commenced after July 1, 2016. Later in the meeting the Board will receive an update on these projects. The floor will open for public comment at the end of the meeting. If you wish to make comments to the board, please fill out a comment card and turn it into Sara Kleinpeter, Board Coordinator.

2. President's Report

Dr. Sullivan provided the following report:

- Noted that commencement season allows for our Board, Leadership Team, faculty and staff to see the successful work done allowing students to complete their training.
- ❖ The state of Louisiana is dealing with a multi-faceted budget situation at this time. Currently, there is an estimated \$310-350 million shortfall for Fiscal Year (FY) 16/17, slower revenue received than anticipated, and a possible \$300 million deficit for FY 17/18. He encouraged Board members to be participatory in the discussion on the budget and to reinforce that continuing to cut higher education to fill the budget hole is not the solution to fixing the state's budget. LCTCS's work is about growing the tax base of Louisiana by providing an opportunity for graduates to contribute to the economy of Louisiana.
- Provided Updates on Colleges
 - Colleges continue to find ways to increase the number of endowments and investments in each college.
 - Central Louisiana Technical Community College (CLTCC) received a \$50,000 investment from CBI and others for a program that results in graduates who are soldiers and putting them into the workforce.
 - Delgado Community College (DCC) opened the Fab Lab at the City Park Campus. Nola Fab Lab provides hands-on learning, and helps to cultivate a passion for science, math, and digital fabrication.

G. GENERAL ACTION ITEMS**

Supervisor Price presented the Academic & Student Affairs Actions agenda items for consideration by the Board.

Academic and Student Affairs Actions

1. For Review and Advisement: Revisions to LCTCS Policy #2.004, "Student Conduct and Appeal Procedure"

No action was taken.

2. Student Referendum for Bossier Parish Community College

On motion by Supervisor Strong, seconded by Supervisor Brown, the Board voted to authorize the Student Government Association of Bossier Parish Community College to conduct a referendum to assess a \$6 per credit hour student athletics fee on all students each semester, capped at 12 credit hours per semester, effective for the 2017 summer term. The motion carried.

Supervisor Carter presented the Facilities Actions agenda items for consideration by the Board.

Facilities Actions

3. Servitude Agreement between Baton Rouge Community College and McDonald's USA, LLC

On motion by Supervisor Smith, seconded by Supervisor Grissette, the Board voted to authorize the President to execute a Servitude Agreement between the LCTCS, on behalf of Baton Rouge Community College, and McDonald's USA, LLC to allow the installation of storm sewer lines and pumping equipment and the continued maintenance of this equipment. The legal description and technical drawing illustrating the area to be transferred will be maintained in the office of the Chief Operations Officer. The motion carried.

4. LCTCS Facilities Corporation Update

Lane Sisung with United Professionals Company, and Tim Barfield and Rory Lato, both with CSRS, provided the Board an in depth presentation of current and future alternative financing projects. UPC and CSRS are the program managers for the activities of the LCTCS Facilities Corporation. The public private partnership (ACT 391 and ACT 360) allows colleges to build facilities using financing methods outside the traditional capital outlay process. The LCTCS Facilities Corporation serves as a private organization and oversees the building process – from start to finish – for new facilities on college campuses that aid in increasing the volume of training and educating students in a modern and effective way, specific to the needs of the community in which the college resides. They detailed the open, transparent process in which providers are chosen for each project. The process allows for opportunity for public input for each project. The presentation by UPC and CSRS can be found in board back up materials.

Supervisor McConduit thanked the project managers for their work in outreach to small or minority business, and asked for specific information on how many small or minority businesses have been selected. CSRS will provide that information to Supervisor McConduit.

Supervisor Smith thanked the Board for their support of this program, and thanked the entire team for their work on these projects. He reiterated that these facilities are needed updates to each college campus that may not have happened through traditional means.

Supervisor Ogé presented the Finance Actions agenda items for consideration by the Board.

On motion by Supervisor St. Blanc, seconded by Supervisor Spears, the Board voted to approve finance policy #5.033 "Fiscal Health Monitoring." The motion carried.

6. Professional Services Contract between the LCTCS Board of Supervisors and the Louisiana State University Economics and Research Policy Group

On motion by Supervisor Carter, seconded by Supervisor Spears, the Board voted to approve a professional services contract between the LCTCS Board of Supervisors and the Louisiana State University Economics and Research Policy Group, effective October 1, 2016 through June 30, 2017. The motion carried.

7. Professional Services Contract between LCTCS Board of Supervisors and Willem Mast Drafting and Design, LLC

On motion by Supervisor Price, seconded by Supervisor St. Blanc, the Board voted to approve a professional services contract between the LCTCS Board of Supervisors and Willem Mast Drafting & Design, LLC, effective November 30, 2016 through November 30, 2017. The motion carried.

8. Approval of the Establishment of a Foundation for Northshore Technical Community College

On motion by Supervisor Smith, seconded by Supervisor McConduit, the Board voted to approve the establishment of a foundation for the benefit of Northshore Technical Community College (NTCC). Staff further recommends that the Board receive and approve the foundation's associated Articles of Incorporation and the Joint Operating Agreement between NTCC and the Northshore College Enhancement Foundation. The motion carried.

On motion by Supervisor Ogé, seconded by Supervisor St. Blanc, the Board voted to appoint Dr. Larissa Littleton-Steib as the chancellor of Baton Rouge Community College with a compensation package consisting of a base salary of \$172,499, a housing allowance of \$20,000, a car allowance of \$5,000 or the use of a state vehicle, and a \$2,500 civic organization allowance, effective January 2, 2017 through June 30, 2019.
