President Sullivan stated, "We appreciate your friendship Mr. McKay, and all you've done to make this project a reality." A video highlighting the construction and its potential for education was shown. Mr. McKay, BRCC Interim Chancellor Michaelis, and BRAF Executive Director John Davies addressed the Board.

Dr. Michaelis noted that he began hearing the McKay name as soon as he arrived into his position at BRCC, and quickly learned how integral a part Mr. McKay would play in developing and executing the design of the facility and the types of training that needs to occur. Dr. Michaelis is pleased to

recommend to the Board the naming of the Baton Rouge Community College Automotive Technology Center after the McKay family.

Mr. McKay expressed his pleasure in the involvement of the creation of this facility. His dad began his teaching career at Melrose Elementary, near the site of the new facility. He is glad that the new facility will allow for positive momentum in the area it sits. He thanked Dr. Michaelis and Mr. Davies, as well as "every person that had a part in this process." Mr. McKay stated, "I am humbled by the remarks made by others, and glad the project will soon move from construction to function, serving the community."

Mr. John Davies made the following comments, "Mr. John McKay was a teacher, a coach, and a principal in East Baton Rouge Parish for 30 years. He was involved in many civic and charitable organizations, and enhanced the lives of many in the community"... "he worked to ensure the youth of the community received quality education...and become better citizens." Mr. Matt McKay had a vision that the young people he hired as technicians at his automotive dealerships could be trained in Louisiana, on equipment relative to the current automotive industry. He approached BRAF in 2009, beginning this process, and has seen it through to fruition. EBR announced it will begin designing a career academy high school next door to the new ATC. He closed by saying, "Coach McKay would be honored to have ATC named for him. A facility that will educate our young people and provide them with the training needed for well-paying jobs. That's what he did for more than 30 years. BRAF is thrilled that the Board consider naming this facility after him."

Supervisors Grissette, Smith, and Toups thanked Mr. McKay, BRAF, and all parties involved to make this vision a success. Mr. McKay and Dr. Michaelis added that the commitment from business has been better than expected, noting that companies are calling and asking for their equipment to be put in this training facility. Mr. McKay is certain that the ATC, once finished, will be the best in the nation at training automotive technicians.

Dr. Sullivan stated a quote he recalled, "Any journey worth travelling is worth a look back to see where you've come from, and certainly a look forward to see where you may go." He addressed Mr. McKay saying, "As you look forward, think back at the 30 years of work your dad did for the area surrounding the ATC and then look forward to the next 30 years, and what is to come."

Chairman Ogé, on personal privilege, asked the Board to vote on the item related to the BRCC Automotive Technology Center. Dr. Sullivan read the recommendation to the Board.

1. Naming of the Baton Rouge Community College Automotive Technology Center

On motion by Supervisor Hardy, seconded by Supervisor Toups, the Board voted to authorize Baton Rouge Community College to name the new Automotive Technology Center, currently under construction and expected to open for classes beginning with the fall semester 2016, to honor long time educator John W. McKay, Jr. The motion carried.

❖ Chair Ogé thanked the LCTCS Leadership Team – the Chancellors, Directors, and Executive Team – for their hard work and assistance during the recent special legislative session, and thanked them in advance for the work to come during the legislative session and potential second special session.

2. President's Report

Dr. Sullivan provided the following report:

- Updates from the Colleges
 - Recent weather events throughout the State have caused flooding at a number of the LCTCS Campuses. Dr. Sullivan thanked the leadership team for their work in securing the campuses and for spending time making sure the students are also taken care of. The only campus that has taken on water that would impact services is the Natchitoches Campus of Northwest Louisiana Technical College. Thankfully, Northwestern State University, and the other campus deans from Northwest Louisiana Technical Colleges, have offered space for classes to take place while the campus is cleaned.
 - South Louisiana Community College has developed a partnership in Lafayette with industry employers to train displaced oil field worker.
 - Central Louisiana Technical Community College Chancellor Sawtelle addressed the Board and shared with them details on the partnership with the Lamar Salter Campus of CLTCC with Bechtel/Cheniere. Bechtel/Cheniere is donating the equipment and educators for this training and working with graduates for job placement. Chancellor Sawtelle also noted the developing relationship with the US Military to train military personnel exiting their service to quickly reach employment.
 - Emily Saleh, LCTCS Executive Director of Enrollment Management & Student Development, addressed the Board. ACT's national annual College and Career Readiness Campaign, to recognize a community college that models exemplary practices in preparing students for transition from high school to college or for career advancement, presented this award to CLTCC. Chancellor Sawtelle and CLTCC

Vice Chancellor of Student Affairs and Enrollment Management, Heather Poole, accepted this award on behalf of CLTCC.

- O Paul Carlsen, LCTCS Vice President of Research, Academics, and Student Affairs, shared with the Board details of the LCTCS/LSU PTK Agreement. In this agreement, students who are members of the Phi Theta Kappa Honor Society, and who transfer to LSU, are eligible for the LSU/LCTCS Promise Transfer Scholarship. There are two parts to the scholarship, first, any LCTCS PTK graduate who earns an associates degree will be granted admission to LSU, and second, those who do attend, will receive an annual scholarship of up to \$5,000 to cover tuition and fees.
- o Dr. Sullivan asked the Board to watch the news on March 24, 2016, for an exciting announcement to come.
- ❖ Jennifer Daly, LCTCS Director of Professional Development, invited the Board to attend the 2016 LCTCS Annual Conference, Our Vision 2020: Investing in Our People, to be held April 14-15, 2016 in Baton Rouge.
- ❖ Budget & Legislative Update

 Dr. Sullivan noted that the legislature met during a special session, and the majority of the 2015-2016 fiscal year budget shortfall was addressed, with little impact on higher education. The legislature now looks forward to the 2016-2017 fiscal year budget that is estimated to have an \$800 million shortfall. There will likely be another special session to address the 2016-2017 fiscal year. Dr. Sullivan provided the Board with an article that details the budget picture, and highlights the potential cuts to higher education.

Though challenges before the LCTCS are ahead, the value that each of the LCTCS colleges offer, in their respective markets, is vital to remember and will be important when the Legislature is considering budget challenges. Dr. Sullivan truly believes that LCTCS will come out of this challenge stronger and better than before. He quoted President Abraham Lincoln, "Let's have faith that right makes might; and in that faith let us, to the end, dare to do our duty as we understand it." The mission of the LCTCS is doing what's right in the State, by empowering individuals to receive training to change lives and create futures.

Staff recommends that the Board authorize Baton Rouge Community College to name the new Automotive Training Center, currently under construction and expected to open for classes beginning with the spring semester 2017, to honor long time educator John W. McKay, Jr. The motion carried.

4. Naming of the Isaac Delgado Hall Theatre at Delgado Community College

On motion by Supervisor Potts, seconded by Supervisor Toups, the Board voted to approve naming the newly renovated Theatre in Isaac Delgado Hall for the late Timothy K. Baker, former Director of the Delgado Theatre Program and Department Chair of Performance and Media Arts. The motion carried.

5. United States Economic Development Administration Grant for South Central Louisiana Technical College, Reserve Campus

On motion by Supervisor St. Blanc, seconded by Supervisor Toups, the Board voted to authorize the President and the Director of South Central Louisiana Technical College to negotiate and execute all documents necessary to receive a \$1.3 million grant from the United States Economic Development Administration to construct and operate a Welding Complex at the Reserve Campus. Approval from the Board of Regents and the Joint Legislative Committee on the Budget may be necessary to facilitate the construction of the Welding Complex. The motion carried.

J. OTHER BUSINESS

On motion by Supervisor Kinney, seconded by Supervisor Austin, the Board voted to approve the following resolution.

In light of the projected revenue shortfall of the State of Louisiana for Fiscal Year 2017 of \$800 million, Louisiana's community and technical colleges will lose \$50-80 million effective on July 1, 2017. This level of cut will decimate two-year college education in Louisiana unless we take steps to reconsider the future of our colleges and system. Given that the current regular session does not allow for consideration of revenue measures and that any potential additional special legislative session will occur on or after the start of the next fiscal year, Louisiana's community and technical colleges must begin to develop plans to re-engineer and recast the future of two-year college education in Louisiana in a manner that is financially viable and sustainable.

By this action, the members of the Board of Supervisors of the Louisiana Community and Technical College System do hereby direct the leadership to study, review, and formulate recommendations in the following four areas and other areas by no later than the April 2016 meeting of the Board of Supervisors:

- 1. Tuition and Fee Schedule for Academic Year 2017 and beyond
- 2. Programmatic and Operational Considerations
- 3. Enterprise Services
- 4. Governance, Financing and Institutional Considerations

The motion carried without objection.
