1. Chair of the Board Report

Chair Hardy provided the following report:

- ❖ Announced to members that Supervisor Helen Carter is home recovering from a recent fall. She is healing well and thanks all for your calls and prayers.
- ❖ Reminded Board members to attend as many of the 2018 Spring Commencement ceremonies that are taking place over the next few weeks. He asked that they let Sara know if you plan on attending and added that an updated schedule was provided to include WorkReady U Graduations.
- Presented the information on a Board Mentorship Program for review by the Board. This will be an item of discussion during the June meeting.
- Presented information related to the addition of a Board Self Evaluation. This will be an item of discussion during the June meeting.
- Recognized Student Board Members Zachary Hitt and Darell Richardson. Noted that Supervisor Richardson was unable to be at the meeting today because of his internship schedule.

Both Supervisor Hitt and Richardson have been active members of the Board for their year's term, and have represented this Board and our System well.

Zachary Hitt is a student at Louisiana Delta Community College and a resident of Winnsboro, Louisiana. He will graduate May 19th with a degree: Business & Technology. Following graduation, he will attend Northwestern State University and study Human Resources.

Darell Richardson, a Donaldsonville native currently residing in New Orleans, is the Technical College Student Representative to the LCTCS Board of Supervisors. He will graduate May 16th, with an Associate of Applied Science degree in Process Technology and looks forward to a career in the field of Process Technology.

Supervisor Hitt stated that he has thoroughly enjoyed his time on this Board as much as he has at his college. He said "I am walking away from this Board with a newfound respect for all members of the Board and also all who work for LCTCS. I've learned that this isn't just a job for all of you, it's a passion…it goes above and beyond for the students, and I thank you for that." He indicated that Supervisor Richardson would echo his statements. He thanked everyone for their support of Supervisor Richardson and him.

- ❖ Informed members that the Council for Student Body Presidents (COSBP) will hold elections on May 14<sup>th</sup> and two new student board members will be elected to our Board. Their terms will begin in June. Once elected, the new members will be announced to the Board.
- Congratulated Supervisor Craig Spohn for being awarded an honorary doctorate degree from Louisiana Tech.
- ❖ Invited Supervisor Smith to share his experience travelling with the students to Amsterdam. He was pleased to join the group to learn about water management in the Netherlands. It was an enriching experience personally coupled with being able to see the growth in the students throughout the trip.

  - 2. President's Report

## Dr. Sullivan provided the following report:

- ❖ Invited the Louisiana Leadership Academy class to be recognized. This year's class is made up of the leadership from the rural campuses throughout the state.
- ❖ Invited Chancellors Wainwright and Strickland to present details related to the recent Netherlands Trip. Northshore Technical Community College, Delgado Community College, Nunez Community College, and Fletcher Technical Community College students participated in a short term study abroad opportunity. Adam Mire, lead faculty at NTCC, and Tomica Duplessis, Dean at DCC joined the chancellors at the table. The course studied the history of water management and included a pre-travel visit to the Water Campus in Baton Rouge and a post travel visit to the New Orleans Sewer and Water Board. The Dutch community is a leader in water management and the students were able to see, first hand, the importance of planning and water management.

Chancellor Strickland reflected on the experience and noted that it is life changing for the students, pointing out that one of the students had never left the state of Louisiana prior to this trip. She noted the two biggest take aways from the trip were:

Students were able to see that the Dutch have discovered a way to live with water. There's a natural push and pull between the community and the water around it.

The visit to the Dutch area related directly back to South Louisiana – a section of a museum visited was dedicated to flooding New Orleans experienced during Hurricane Katrina.

- Noted that a Bossier Parish Community College 50<sup>th</sup> Anniversary ink pen is at each station. Chancellor Bateman introduced to the Board the BPCC Debate Team. The debate team recently won the national debate tournament championship.
- Louisiana had two national scholars recognized during the Phi Theta Kappa All-Louisiana Ceremony on April 27, 2018. Ariel Alonzo from Delgado Community College received the New Century Transfer Scholar Award a \$2,250 scholarship and Timothy Masterson from Nunez Community College received the inaugural New Century Workforce Scholar Award a \$1,250 scholarship.
- Congratulated Baton Rouge Community College Speech Instructor, Molly Russell, for being awarded the AACC Dale Parnell Distinguished Faculty Award. This award recognizes individuals who are making a difference in the classroom.
- ❖ Northshore Technical Community College has been named one of the Greater New Orleans Top Workplaces in 2018. The Times-Picayune and NOLA.com will host a celebration honoring all 50 companies chosen by their employees as a Top Workplace on Thursday, May 24th at the Ernest N. Morial Convention Center.
- ❖ All nine students in the new Line Worker program at Fletcher Technical Community College graduated on Monday and all received full-time employment offers. That is 100% retention, 100% job placement with all starting at \$23/hour. The next class is set to begin on June 11.
- Recognized the Louisiana Chemical Association Curriculum Designation for many programs across the state. He thanked David Lafargue, Dean of Industrial Technology at SOWELA, Rodney Trahan, Training Specialist for Westlake Chemical, and Dr. Rene Cintron, LCTCS Chief Academic Affairs Officer, for spearheading this revision of the PTech Curriculum throughout the system.
- ❖ Provided a legislative update. Spent Thursday in the Senate Finance Committee meeting. Members of the committee were very complimentary of the work being done by LCTCS, and all of higher education in the state. The continued discussion that puts higher education against healthcare is unfortunate and frustrating. Dr. Sullivan hopes that the leadership of the legislature comes together to find a solution that is right for Louisiana.
- Reminded the Board that many community college systems in the nation are funded through local dollars, in addition to state and tuition/fee support. LCTCS does not receive local funding, leaving the tuition/fees to make up for the shortfall from the state budget. In the June Board meeting, the tuition and fee schedule will be discussed at length.
