F. REPORTS

1. Chair of the Board Report

Chair Ogé provided the following report:

- ❖ Northshore Technical Community College (NTCC) was awarded a grant from the Council on International Educational Exchange, its first CIEE Generation Study Abroad Access Grant.
- ❖ Praxair announced additional funding for the Skills Pipeline program in Louisiana for 2016. Approximately 100 new welders from Baton Rouge Community College, Delgado Community College and SOWELA Technical Community College graduated from this accelerated one-year program in 2015.
- ❖ South Central Louisiana Technical College will host a groundbreaking of the new Hugh & Byrnes Young Marine & Petroleum Safety Training Center today at 1:00 p.m. Because of the recent wet weather, the ceremonial groundbreaking will be held in the Morgan City Auditorium.

2. President's Report

Dr. Sullivan provided the following report:

❖ Recognized Shell Pipeline Company for their investment in students through academic scholarships. Representing Shell at the meeting was David Escabar, Shell's Workforce Development Specialist of Crafts and Operations. Shell established scholarship programs to incentivize students to pursue careers in the oil & gas, petro chemical and maintenance craft labor fields.

Dr. Sullivan congratulated the students on their achievements, noting that the Board and he are extremely proud of each of them, reminding the students to "take advantage of the opportunities ahead."

Following the presentation by Shell to the students, two student scholarship recipients addressed the board.

José Ortis addressed the board and shared the following words: "Without this scholarship, I wouldn't be the person that I am today. It has allowed me to continue my education in a trade that I've found passion. I am so thankful for having this education and know that I have a future to look forward to. This scholarship has helped me to better myself in a way that I wouldn't have been able to without it."

Brandy Green thanked the Board for allowing her the opportunity to address them. She made the following comments to the Board. "I am incredibly honored to be here today...I went back to school in instrumentation, and haven't looked back since. This scholarship...is a blessing. Going to school full time, working full time, and being the best mom that I can be is not the easiest thing in the world. Right now, being here before you has made everything worth it...I wanted to give up so many times...but thought about my son and thought what kind of mom I would be if I gave up...What does the scholarship mean? I had the patience, dedication, and strength and great amount of sacrifice...to graduate and now I can do anything...Thank you for everything...for every chance...for believing in me."

Supervisor Smith asked for the details of the award. Mr. Escabar noted that the scholarships are a Craft & Associate Degree scholarship program. Scholarships are worth \$1,800-2,200 each. Students have to have 2.5 GPA or above to obtain and retain for 2-3 years, depending on the students' circumstances.

- ❖ South Central Louisiana Technical College Director, Earl Meador, welcomed the Board to St. Mary Parish. He thanked Shell for their involvement in the community. He is excited about the groundbreaking for the Marine Center and knows it will continue to enhance the program.
- ❖ Delgado Community College, Fletcher Technical Community College, South Louisiana Community College, and SOWELA Technical Community College have been named The Best Community Colleges in Louisiana for Workforce Training by Southern Business & Development Magazine. Congratulations to the schools and their chancellors.
- ❖ Board of Regents approved the application of 13 LCTCS colleges for designation as a Governor's Military and Veteran Friendly Campus. With this designation, LCTCS will be the only system in the state with all campuses with this designation.
- ❖ This month, Fletcher Technical Community College's ASN program received tentative approval by the ACEN the nursing accreditation body for Community College Registered Nursing Programs. Final approval will be issued in the spring of 2016. This was a six year journey for the college. Congratulations to Chancellor Meador, Dr. Sonia Clark and the ASN staff at Fletcher.
- ❖ Referenced the bill introduced by US Congressman Cedric Richmond the Jobs Act. A copy of the press release and details about the bill have been provided to each member at their station.
- ❖ Additionally, Board members were provided with a copy of the quarterly System Matters document. An electronic copy will be sent as well.

In accordance with R.S. 38:2212.1, the demolition of this building requires the approval of Facility Planning and Control and the notification of the appropriate legislators. The motion carried.

6. Disposal of Modular Buildings at South Central Louisiana Technical College Young Memorial Campus

On motion by Supervisor Austin, seconded by Supervisor St. Blanc, the Board voted to approve the disposal of seven (7) modular buildings at the South Central Louisiana Technical College (SCLTC) Young Memorial Campus. In accordance with R.S. 38:2212.1, the disposal of these buildings requires the approval of Facility Planning and Control and the notification of appropriate legislators. The motion carried.

7. Servitude and Right of Way Agreement from the LCTCS, on behalf of Delgado Community College, to the Sewer and Water Board of New Orleans

On motion by Supervisor Potts, seconded by Supervisor Kinney, the Board voted to authorize the President to execute a right of way agreement between the LCTCS, on behalf of Delgado Community College, and the New Orleans Sewer and Water Board for the repair and upgrade of the water, sewer and drain lines and the continued maintenance of the lines at the Westbank Campus. A copy of this agreement must be filed with the local Clerk of Courts and the State Land Office. The motion carried.

8. Servitude and Right of Way Agreement from the LCTCS, on behalf of SOWELA Technical Community College, to Entergy Louisiana, LLC

On motion by Supervisor Mount, seconded by Supervisor Austin, the Board voted to authorize the President to execute a right of way agreement between the LCTCS, on behalf of SOWELA Technical Community College, and Entergy Louisiana, LLC for the connection of electrical service and the continued maintenance of the utility distribution equipment to be installed to service the new Regional Training Center in the area depicted in the attached illustration. A copy of this agreement must be filed with the local Clerk of Court and the State Land Office. The motion carried.

Reauthorization of Enterprise Resource Planning (ERP) Fee On motion by Supervisor Hemperley, seconded by Supervisor Hardy, the Board voted to authorize that the Enterprise Resource Planning (ERP) fee be increased from \$3 to \$5 per student credit hour effective for the spring 2016 semester at all LCTCS colleges. The motion carried.
- 11. Memorandum of Understanding between LCTCS and the Board of Elementary and Secondary Education (BESE) Career and Technical College Education Programs On motion by Supervisor Smith, seconded by Supervisor Price, the Board voted to approve the Memorandum of Understanding (MOU) between the LCTCS Board of Supervisors and the Board of Elementary and Secondary Education (BESE) for administration of the secondary career and technical education portion of the Carl D. Perkins funds for fiscal year beginning July 1, 2015 and ending June 30, 2016. The BESE approved and signed the MOU at their July Board Meeting. The motion carried.
