E. APPROVAL OF SEPTEMBER 10, 2014 AGENDA

On motion of Supervisor Carter, seconded by Supervisor Toups, the Board voted to approve the September 10, 2014, agenda as amended. The motion carried.

F. APPROVAL OF MEETING MINUTES OF JUNE 11, 2014 On motion of Supervisor Brown, seconded by Supervisor St. Blanc, the Board voted to approve the minutes of June 11, 2014, meeting. The motion carried.

G. REPORTS

1. Chair of the Board Report

Chair Ogé invited Board of Regents Chairman, Bubba Rasberry to address the Board. Chair Rasberry spoke with the board members about the importance of the Board, especially during this time in Louisiana right now.

He stated that he is "Privileged to be here on behalf of the Board of Regents...All education systems are working with the spirit of collaboration to achieve a greater goal – the goal of producing qualified graduates that meet the needs of the current and future economic plans of our state...we are responsible for framing, leading the conversation...The real job is to focus on the students...we have the unique opportunity to lead the nation in creating a talented workforce..."

In reflecting on the past and growth of the LCTCS and other higher education systems, Chair Rasberry noted "we are still learning how to grow, but together we are headed in the right direction."

Of the Workforce and Innovation for a Stronger Economy (WISE) Fund, he noted "...there has never been a clearer, more tangible plan to address the linkage between higher education and workforce until now."

Chair Rasberry noted that "the WISE Framework is built on education and training which drives innovation, fuels investment and propels economic competitiveness...This Board and System will play an intricate part in carrying out the role, scope and mission of WISE."

Chair Rasberry explained that all systems have worked together to allocate WISE funds in a strategic matter, to fulfill the needs of the State of Louisiana and future economic opportunities.

Chair Rasberry stated two commitments to the LCTCS Board of Supervisors. The first is to "work with each of you to see this system grow...the Regents understands the significance and believes in the workforce rapid response fund..." and, second, to

"engage in a complete review of higher education's resource allocation to ensure the allocated funds are aligned with each systems mission and its institutions."

Chair Rasberry is "convinced that LA must adopt a model of resource allocation that is strategic in its approach rather than simply funding institutions....must use the entire education resource to ensure that we fund the gaps in workforce so that Louisiana can thrive and compete economically."

Chair Rasberry hopes to continue this spirit of dialog, understanding, and cooperation between the higher education systems and is committed to advance higher education in this state. He thanked the Board for allowing him to speak and looks forward to a continued partnership.

Chair Ogé thanked Chair Rasberry for his kind words of encouragement and leadership on the WISE Counsel. President Sullivan thanked Chair Rasberry for his address to the Board and for his leadership in working towards advancing higher education in the state of Louisiana.

Chair Ogé congratulated the LCTCS leadership team for their courage in looking towards the future and the paths of workforce development in the state. The Board is available to assist the leadership team however needed.

Chair Ogé wished River Parishes success in their grand opening ceremonies scheduled for later in the day.

• Invited Salzburg Institute participants Dr. Natalie Harder, SLCC Chancellor, Alex McEntyre, NTCC Student Body Association President, and Margaret Keller, NTCC Library Director to address the Board about their experience. Ms. Leah Goss, Senior Vice President of System Advancement joined the delegation at the table. A video highlighting the 2014 Salzburg Institute trip was shown to the assembly. Following the video, Ms. Goss reported that the LCTCS Foundation has sponsored this initiative for six years and there are nine colleges participating on an annual basis. Once participating in the program, there is an impact on our colleges by looking at ways a global perspective can permeate throughout a campus. Ms. Goss thanked Dr. Derrick Manns for his leadership each year in accompanying the delegation.

SLCC Chancellor, Dr. Natalie Harder shared her thoughts on the need to globalize the learning environment of our students, to prepare them for potential experiences in the workforce.

Northshore Technical Community College student and Student Body Association President, Alex McEntyre, shared his experience at the Salzburg Global Seminar with the Board. Since the seminar, he has formed a strong interest in volunteer work and sustainable living and is working to put sustainable procedures into effect around campus. He stated, "I see things differently now, and believe that this trip has made me a better individual and leader. Thank you."

Ms. Margaret Keller, Library Director at Northshore Technical Community College, spoke to the Board about the impact the seminar has on the faculty that attend. This year, the attendees from LCTCS returned from the institute with the intent to make a system wide change to global awareness. The 2014 faculty participants have formed a task force to talk to former Salzburg fellows to share ideas. This task force will be sending a survey on how to best collaborate ideas and will share their findings with the system office.

Supervisor Stevie Smith noted, as a fellow attendee, the impact that this seminar has on every person that attends. He inquired with Ms. Goss about the number of attendees over the years. Ms. Goss noted that around 100 students and faculty have attended. Supervisor Smith reminded the Board that the attendees raise the funds to attend this seminar and are active participants in the seminar.

Supervisor Bob Brown is pleased to hear that the program has expanded to most of the colleges participating in the seminar. He asks that the fellows report on their findings throughout the year, resulting in the Board's help and involvement, rather than an annual report.

Supervisor Potts suggested that the system track the former participants and report on their successes as they relate to the seminar. He feels this would be a helpful tool in engaging attendees, both former and future. Ms. Goss thanked him for his suggestion and said it would be possible.

Dr. Sullivan shared his recent experience with a former LCTCS student, and Salzburg seminar alumni, who is now a student leader in one of the four year systems in Louisiana. This student credited the Salzburg experience as a foundation for his leadership experience.

Central Louisiana Technical Community College (CLTCC) is a comprehensive public two-year community college that provides academic, occupational and specialized training leading to industry-based certifications, technical certificates, diplomas, and associate degrees. CLTCC also responds to the needs of the community by providing personalized enrichment for individuals and customized adult education for educationally disadvantaged populations. Using innovative educational strategies, the college creates a skilled workforce and prepares individuals for advanced educational opportunities.

2. Accreditation Updates

(From the SACSCOC Board of Trustees meeting on June 19, 2014.)

- a. L. E. Fletcher Technical Community College Reaffirmed
- b. SOWELA Technical Community College Initial Accreditation Level I
- c. Baton Rouge Community College accepted the prospectus for merger/consolidation and authorization of a substantive change committee

Dr. Sullivan noted that twice a year, the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) meets to take action on various colleges. From this date on, twice a year - in September and January/February, there will be an update item on the LCTCS Board Agenda related to the actions of this organization.

This June, the SACSCOC Board of Trustees took action on three of the LCTCS Colleges: the reaffirmation of L. E. Fletcher Technical Community College for ten years; the BRCC merger consolidation and authorization of a substantive change committee application was approved; SOWELA received approval for an initial accreditation, Level 1.

Dr. Sullivan invited SOWELA Chancellor, Neil Aspinwall, to address the board on the approval process. SOWELA began this application process nearly ten years ago. In April 2012, SOWELA was admitted as a candidate, fulfilling 26 standards for candidacy. The team took part in an 18 month period of going through 90 standards and SACSCOC gave no recommendations. In June 2014, SOWELA was approved as an accredited SACSCOC university. Chancellor Aspinwall thanked the Board for their support throughout the lengthy process.

Chair Ogé congratulated SOWELA and Chancellor Aspinwall on the successful approval of this accreditation.

Supervisor Smith presented the Facilities Actions agenda items for consideration.

Facilities Actions

3. Servitude and Right of Way Agreement from LCTCS, on behalf of SOWELA Technical Community College, to Entergy Gulf States Louisiana, LLC and CenterPoint Energy

On motion by Supervisor Mount, seconded by Supervisor Toups, the Board authorized the President to execute two Right-of-Way Agreements between Entergy Gulf States Louisiana, L.L.C. and CenterPoint Energy and the LCTCS, on behalf of SOWELA Technical Community College, for connection of electrical and gas service and the continued maintenance of the utility distribution equipment to be installed to service a new facility at the Chennault Airpark. The motion carried.

4. Lease Agreement for Property at Baton Rouge Metro Airport for Baton Rouge Community College

On motion by Supervisor Toups, seconded by Supervisor Gamble, the Board authorized the President and the Chancellor of Baton Rouge Community College to negotiate and execute a lease between the LCTCS, on behalf of Baton Rouge Community College, and Landmark Baton Rouge, L.L.C. for a 10,000 square foot hangar at the Baton Rouge Metro Airport, at a maximum cost of \$120,000 per year. This lease must be approved by the Division of Administration, Office of Facility Planning and Control. The motion carried.

 Cooperative Endeavor Agreement between LCTCS, on behalf of SOWELA Technical Community College, and Louisiana Department of Economic Development

On motion by Supervisor Mount, seconded by Supervisor Grissette, the Board authorized the System President to negotiate and execute a Cooperative Endeavor Agreement between the LCTCS and the Louisiana Department of Economic Development to improve a training facility on the SOWELA Technical Community College Campus, in accordance with inducements offered by the Louisiana Department of Economic Development to AAR Aircraft Services, Inc. The CEA will provide facilities to assist AAR Aircraft in creating and maintaining jobs in the Lake Charles. This agreement requires the approval of the Division of Administration Office of Contractual Review. The effective date of the agreement will be immediately upon the approval of the Division of Administration Office of Contractual Review. The motion carried.

- 6. Transfer of Property for Improvements Authorized in Act 360 of 2013:
 - a. Baton Rouge Community College Foundation to Baton Rouge Community College for the Ardendale (Smiley Heights) Campus

On motion by Supervisor Fisher, Seconded by Supervisor Carter, the Board authorized the transfer of up to 30 acres of property, located on the northwest corner of Lobdell Boulevard and Renoir Avenue, Baton Rouge, Louisiana, from the Baton Rouge Community College Foundation to the LCTCS, on behalf of Baton Rouge Community College. Once completed, staff will record this acquisition with the State Land Office. The motion carried.

b. BPCC Foundation Inc. to Bossier Parish Community College for the STEM Building

On motion by Supervisor Gamble, seconded by Supervisor Spohn, the Board authorized the System President to receive approximately 9.920 acres of land from the BPCC Foundation, Inc. for the STEM Building at Bossier Parish Community College, at the intersection on the south side of East Texas Street and east side of Cavalier Drive, as reflected on the attached aerial photo. Once completed, this acquisition will be recorded with the State Land Office. The motion carried.

Following a brief discussion, and on motion by Supervisor St. Blanc, seconded by Supervisor Hemperley, Supervisor Spohn noted on record that he is the Executive Director of the Cyber Innovation Center, National Science Research Center, the entity donating the 9.920 acres of land in this transaction.

c. The Rapides Foundation to Central Louisiana Technical Community College for the Alexandria Campus

On motion by Supervisor Hardy, seconded by Supervisor St. Blanc, the Board authorized the LCTCS President to execute a transfer of Blocks 36 and 37, located on Fifth and Sixth Streets and bordered by Jackson and Murray Street located in the Central Business District of Alexandria, Louisiana from The Rapides Foundation, on behalf of Central Louisiana Technical Community College, for construction of a campus in Alexandria. When completed, staff will record the transaction in the State Land Office. The motion carried.

d. Louisiana Delta Community College Foundation to Louisiana Delta Community College for the Jonesboro Campus

On motion by Supervisor Price, seconded by Supervisor Banks, the Board authorized the System President to execute documents necessary for transfer of Lots 3 and 4, Jonesboro Industrial Park Unit 1, at 254 Industrial Drive, Jonesboro, Louisiana, from the Louisiana Delta Community College Foundation to LCTCS, on behalf of Louisiana Delta Community College, for construction of the Louisiana Delta Community College, Jonesboro Campus. Once completed, this acquisition will be recorded with the State Land Office. The motion carried.

e. LCTCS Foundation to Northshore Technical Community College for the Lacombe Campus

On motion by Supervisor Carter, seconded by Supervisor Murphy, the Board accepted the transfer of a 12.6 acre parcel of land, located on Tamanend Way in Lacombe, from the LCTCS Foundation, on behalf of the Northshore Technical Community College, to the LCTCS, to be used as the site for a new campus in Lacombe for the Northshore Technical Community College, as reflected on the attached map. Staff will record this acquisition with the State Land Office. The motion carried.

f. LCTCS Foundation to Northshore Technical Community College for the Livingston Campus

On motion by Supervisor Carter, seconded by Supervisor Murphy, the Board authorized the LCTCS President to execute a transfer of an approximate 12.27 acres of land from the LCTCS Foundation for construction of a Livingston Parish campus for the Northshore Technical Community College. The Phase 1 site assessment and cooperative endeavor agreement are still pending. Upon execution, staff will record this acquisition with the State Land Office. The motion carried.

g. LCTCS Foundation to South Central Louisiana Technical College for the Reserve Campus

On motion by Supervisor Brown, seconded by Supervisor Hemperley, the Board authorized a transfer of 6.5 acres of land, located at US Highway 61 and Regala Street in Reserve, from the LCTCS Foundation, on behalf of South Central Louisiana Technical College, to LCTCS, to be used for the location of new workforce training facilities for South Central Louisiana Technical College, Reserve Campus. Staff will record the transfer of the land in the State Land Office. The motion carried.

Supervisor Toups noted for the record that Supervisors Ogé, Gamble, Smith and Toups also serve on the Board of Directors for the LCTCS Foundation.

Supervisor Grissette presented the Finance Actions agenda items for consideration.

On motion by Supervisor Potts, seconded by Supervisor Carter, the Board approved the Memorandum of Understanding (MOU) between the LCTCS Board of Supervisors and the Board of Elementary and Secondary Education (BESE) for administration of the secondary career-and technical education portion of the Carl D. Perkins funds for the fiscal year beginning July 1, 2014 and ending June 30, 2015. The Board of Elementary and Secondary Education approved and signed the MOU at the July Board Meeting. The motion carried.

9. Approval of Louisiana's 2014-2015 Perkins Allocation for Distribution

On motion by Supervisor Toups, seconded by Supervisor Brown, the Board approved the distribution of Perkins funds to the statewide eligible recipients including the Louisiana Department of Education upon the receipt of the award letter from the U. S. Department of Education, Office of Vocational and Adult Education. The state's total allocation will be \$21,560,878, unchanged from Fiscal Year 2013-14. Note: The regular allocation for 2014-15 remained \$21,041,943. An additional allocation of \$518,934.83 from Carryover funds is included on the breakdown provided. The motion carried.
