I. November 2022 Financials

Revenue

At the end of November, membership revenue for the month was \$229,433.65. Through the first five months of the fiscal year, the overall revenue was \$1,096,343.61.

Expenses

Expenditures for the month totaled \$94,243,45.

<u>President's Report:</u> C.C Copeland gave an update on the repair of the WLPB tower guywires. Funding will come from the state's major repair budget. The cross beams on the tower are also in need of repair. C.C discussed LPB's preliminary funding request for the state budget which will include: a transmitter and antenna for Baton Rouge, intercom system, computers, a new automation system, electrical re-wiring,

studio lights, and three vehicles. The new LPB documentary, *The Precipice*, will air on Thursday, March 9 and LPB is coordinating a private screening for the Pointe-au-Chien tribe. The film follows the tribal community as it tries to save its way of life. Antiques Roadshow will be in Baton Rouge in May to record shows for 2024. This is a great opportunity for LPB. Friends of LPB is planning a ticketed VIP Experience and people can also register for free tickets through a lottery organized by Antiques Roadshow. C.C presented the architectural designs for the lobby refresh and gave an update on the timeline.

<u>Chairman Report:</u> Chris Wegmann asked about Board vacancies. C.C reported on the status of open positions. Chris also asked about the status of Board members of public agencies being able to attend Board meetings by Zoom. Matt reported a legislative task force is looking into this issue. The task force will provide a report to the legislature on their findings.

<u>Other Business:</u> Sonny Cranch asked about broadcast vs. streaming audience. C.C said more and more viewers are eliminating cable and are streaming. Matt presented a Board resolution, in keeping with similar resolutions for past CEOs, that would allow C.C to officially conduct agency business on the Board's behalf. Chris Wegmann read the resolution and asked for a motion. A motion was made by Dr. Tina Holland and seconded by Eartha Cross. Motion carried.

<u>Adjournment:</u> Chris Wegmann adjourned meeting at 12:59 PM after a motion by Sonny Cranch and a second by Dr. Tina Holland.
