The Board was given a copy of a revised Executive Director job description, attached hereto as Attachment B, for approval. A motion was made by Michele Sutton and seconded by Dr. Godbee to approve the updated description as presented. The motion was approved after a unanimous vote in the affirmative.

Executive Director Report Trauma System Consultation

Paige Hargrove, LERN Executive Director, announced that the virtual meeting regarding the Trauma System Consultation will be on March 12, 2024; and will include a presentation on the process of how the consultation works and a presentation by LERN. March 25, 2024 will be the

full day, in-person consultation to be held at Lod Cook. Members were encouraged to attend both. No formal action was taken by the Board.

Board Appointments

Executive Director Hargrove announced new Board member, Dr. Patrick Smith, Trauma Medical Director at Francis Medical Center, Monroe, representing hospitals with more than 100 beds

The Board discussed vacancies in the Board seat for legislators and discussed some legislators who were viewed to be good LERN Board members. No formal action was taken by the Board.

Executive Director Report Board Officer Elections 1/18/2024

The floor was opened for nominations for officers for the LERN Board.

For the position of treasurer, Jack Varnado nominated Karen Wyble and Dr. Wyble accepted. There being no other nominations, Dr. Wyble was elected treasurer.

For the position of Vice Chair, Paige Hargrove communicated Dr. Grainville Morse volunteered to serve as Vice Chair. There being no other volunteers or nominations, Dr. Morse was elected Vice Chair.

For the position of Chair, Dr. Garrett nominated Dr. John Jones, who accepted the nomination. There being no other nomination, Dr. Jones was elected Chair.

For the Executive Committee, the members are Chair, Vice Chair, Treasurer, Immediate Past Chair, and one LDH appointment, Dr. Joseph Kanter.

The Board is to elect two executive committee members and was advised that one of the two has in the past been an EMS representative. Ms. Hargrove communicated Porter Taylor, prior to the board meeting, communicated he wanted to volunteer to serve as a member, the EMS representative. Additionally, Dr. John Hunt volunteered to serve for the second position. However, since Dr. Hunt has served three terms on the Executive Committee, the rules require that service of a fourth term be authorized by the Board. Dr. Zweifler made a motion and Dr. Jones seconded to allow Dr. Hunt to serve a fourth term on the Executive Committee. The motion was approved after a unanimous vote in the affirmative.

Dr. Jones made a motion seconded by Ms. Sutton to elect Dr. Hunt and Taylor Porter to serve on the Executive Committee. The motion was approved after a unanimous vote in the affirmative.

Ms. Hargrove thanked Dr. Garrett for the incredible hard work and service to the Board as Chair over the past year. A plaque was presented to Dr. Garrett memorializing here service as Board Chair. No formal action was taken by the board.

Report out on 2023 Strategic Goals

Executive Director Hargrove presented a close out on the 2023 Strategic Goals for LERN. See <u>Attachment C</u>. No formal action was taken by the board.

Open Meetings Policy

Executive Director Hargrove advised the Board that disabled public and disabled Board members may attend Board meetings and commission meetings virtually. Ms. Hargrove presented a Board policy to facilitate such virtual participation in Board meetings. Ms. Hargrove presented a drafted policy for consideration, including some executive committee additions to the policy. See Attachment D. A motion was made by Ms. Sutton and seconded by Dr. Morse to accept the draft policy as amended by the executive committee. The motion was approved after a unanimous vote in the affirmative.

Region 6, 7 and 8 Commission Update

Executive Director Hargrove presented a powerpoint presentation (see <u>Attachment E</u>) highlighting the programs and improvements in Regions 6, 7 and 8. No formal action was taken by the board.

2023 LERN Call Center Report
