State Plan on Aging:

Every four years GOEA is required to submit for approval a State Plan to its Federal partner, the Administration for Community Living (ACL), that provides goals and objectives related to assisting older residents, their families and caregivers. This plan is due July 2023. The Compliance and Planning Unit under the leadership of Cheri Crain is tasked with preparing the Plan for submission. The Home and Community Based Services Unit under the leadership of Shavon Humphrey provides the assistance needed to the Area Agencies on Aging to prepare their four-year area plans that will be become a part of the state plan.

Disaster Update:

Kayla Doyle, Disaster Coordinator at GOEA sent a survey to Councils on Aging and Area Agencies in the northeast parishes after the November 29, 2022 weather event. The responses to the survey indicated that there were no issues from the weather event. Wednesday, November 30, 2022 marked the end of the Atlantic hurricane season. There were 14 named storms and 8 hurricanes (2 CAT 3+) and they all missed Louisiana. Let's be grateful. We are also thankful for recent federal support to aid in the ongoing recovery from Hurricanes Laura, Delta and Ida.

Senior Services:

We reported to you last quarter the number of units of services provided. This quarter we want to report on just who we are serving. Thanks to data received from the resident guru, Timothy Jones, I am able to present to you demographics for the population served for the federal fiscal year ending September 2022 on the attached chart. I want to also thank Jessica Ross, ADRC Manager for taking the demographics and putting into the great chart presentation on the attachment. Jessica is another IT genius at GOEA.

LACOADA: Presented by Ms. Darlene Schexnayder: The annual conference will be held January 24 - 25, 2023 ^tat the Clarion Inn Conference Center in Gonzales, Louisiana. The trainings focus on training needs for the directors, i.e., human resources, best practices, COVID, etc. The conference will start around noon on the first day, 9:00 a.m. on the second day and end at noon on the third day. Discussed having the LEBA Quarterly meeting on January 25th at the conference.

<u>LANA</u>: Presented by Ms. Debbie Fleming: The annual conference just ended and was great. Next year's annual conference is scheduled for August 15 - 16, 2023 at the L'Auberge Casino in Baton Rouge, Louisiana. The challenge for the annual conference next year is to gain new members and sponsors. Membership is \$50 a year and the conference fee is \$150. Trainings discussed included active shooter, people's choice, and partnering with AARP for a candidate for governor forum.
