CALL TO ORDER

The meeting was called to order at 9:36 a.m. by Mr. Fred Bass, Confidential Assistant to Commissioner Dr. Mike Strain.

Motion to approve the proceedings as written from the April 19, 2017 Louisiana Agricultural Chemistry and Seed Commission meeting was made by Mr. Michael Hensgens and seconded by Mr. Don Philley. Motion approved unanimously.

ESTABLISH DATE FOR NEXT COMMISSION MEETING

LDAF staff recommended a tentative date of April 18, 2018 for the next commission meeting.

OLD BUSINESS

Lester Cannon gave an update on Seed Programs Division, including the status of the proposed Seed Program rule changes presented at the April 19, 2017 meeting. Mr. Cannon informed the commission that the rules went into effect October 20, 2017, and there were no negative comments or opposition. He followed with an update on recent changes to the Louisiana Agricultural Chemistry and Seed Commission members as a result of changes in the LSU system and the resignation of Mr. Don Philley from the commission. Dr. Eric Webster named as member representing Louisiana Cooperative Extension Service with Dr. Ed Twidwell as his designee; Dr. Christine Navarre as designee for Dr. Philip Elzer; Mr. David Causey was recommended by LAIA as the Fertilizer Industry's replacement for outgoing member Don Philley.

Dr. Mark LeBlanc gave an update on the Agricultural Chemistry Feed, Fertilizer and Agricultural Liming Programs. He also informed the commission of the staff's increased efforts on more focused sampling process, the status of the Animal Feed FDA grant and the ISO accreditation. He also updated the members on transitioning the Fertilizer and Lime programs to an online registration and tonnage entry system via the USAPlants software.

NEW BUSINESS

Approved Plant Breeder Application

LDAF staff recommended acceptance of the application for Approved Plant Breeder from Dr. Adam Famoso, with the LSU AgCenter H. Rouse Caffey Rice Research Station.

Motion: Mr. Michael Hensgens made a motion to accept Dr. Famoso's application. Mr. Don Philley seconded the motion. Motion passed unanimously.

ADJUDICATORY HEARING

Mr. Fred Bass turned over the meeting to hearing officer, Mr. Michael Heier, Assistant Attorney General.

Seed Programs Division Cases

Seed Programs Division Case Number 18-01 – Lowe's Home Centers #589

Lowe's Home Center #589 was charged with one violation of the Louisiana Seed Law R.S. 3:1440 for violation of a written Seep Programs Division Stop Order.

Ms. Tabitha Gray entered exhibits LACS 1 and LACS 2 into evidence as the findings of facts and conclusions of law. LACS 1: charge letters sent via certified mail with signed receipts. LACS 2: signed, witnessed and notarized stipulations between the LDAF and Respondent. Mr. Michael Heier, hearing officer, accepted the evidence as presented.

The Seed Programs Staff recommended a penalty of Five Hundred Dollars (\$500.00) for the violation, with no suspension of penalty due to Respondent's probationary status from a previous case.

It was further recommended that the waived portion of the penalty, Two Hundred and Fifty Dollars (\$250), from Case 17-02 become immediately due and payable due to violation of the terms of the stipulation agreement by Respondent.

Motion to accept the stipulation letter as the findings, facts and conclusions of law, to accept the recommended penalty of Five Hundred Dollars (\$500.00) for Case 18-01 and to accept the recommended recovery of the suspended penalty of Two Hundred and Fifty Dollars (\$250.00) for Case 17-02 for a total penalty of Seven Hundred and Fifty Dollars (\$750.00) was made by Mr. Michael Hensgens and seconded by Mr. Ed O'Neal. Motion passed unanimously.

Seed Programs Division Case Number 18-02 – Tractor Supply Company #1177

Tractor Supply Company #1177 was charged with two violations of the Louisiana Seed Law R.S. 3:1440 for violation of a written Seed Programs stop Order.

Ms. Tabitha Gray entered exhibits LACS 1 and LACS 2 into evidence as the findings of facts and conclusion of law. LACS 1: charge letters sent via certified mail with signed receipts. LACS 2: signed, witnessed and notarized stipulations between the LDAF and Respondent. Mr. Michael Heier, accepted the evidence as presented.

The Seed Programs Division Staff recommended a penalty of One Thousand Dollars (\$1,000.00) for the violation. The Staff also recommended that Five Hundred Dollars (\$500.00) of the penalty be suspended due to the Respondent's past compliance record. Seed Programs Division Case Number 18-03 – Walmart Store #415

Walmart Store #415 was charged with one violation of the Louisiana Seed Law R.S. 3:1440 for violation of a written Seed Programs Division Stop Order.

Ms. Tabitha Gray entered exhibits LACS 1 and LACS 2 into evidence as the findings of facts and conclusion of law. LACS 1: charge letters sent via certified mail with signed receipts. LACS 2: emailed copy of signed, witnessed and notarized stipulations between the LDAF and Respondent. Mr. Michael Heier accepted the terms of the provisional stipulations pending completion of the original documents.

The Seed Programs Staff recommended a penalty of Five Hundred Dollars (\$500.00) for the violation. The Staff also recommended that Two Hundred and Fifty Dollars (\$250.00) of the penalty be suspended due to Respondent's past compliance record. The Commission accepted the department's recommendation and offered no modifications.

Motion to accept the provisional stipulation as the findings of fact and conclusions of law and to accept the recommended total fine of Two Hundred and Fifty Dollars (\$250.00) was made by Mr. Michael Hensgens and seconded by Mr. Ed O'Neal. Motion passed unanimously.

Seed Programs Division Case Number 18-04 – Walmart Supercenters #2706

Walmart Supercenters #2706 was charged with two violations of the Louisiana Seed Law R.S. 3:1440 for violation of a written Seed Programs Stop Order.

Because Humboldt Bottling did not sign and return the stipulation that was enclosed with the charge letter, Ms. Angelle Pearson was called to testify on behalf of the Louisiana Department of Agriculture and

Forestry. Mr. Michael Heier, hearing officer, accepted the evidence. Ms. Pearson testified that the exhibits had not been tampered with in any way and also stated that Humboldt Bottling had recently canceled their company's registration with the LDAF. Mr. Michael Heier, hearing officer, accepted the evidence presented in front of the commission.

Agricultural Chemistry Division Case Number AC17 – 12 – Progressive Turf

Progressive Turf was charged with four (4) violations of the Louisiana Fertilizer Law R.S. $3:1411 \ et seq.$, particularly, R.S. 3:1417(A)(8) – failure to timely file quarterly tonnage reports and pay inspection fees. Ms. Pearson stated that she and other LDAF staff had made multiple attempts to contact Progressive Turf both by email and phone, but none of those attempts was acknowledged or returned. Mr. Michael Heier, hearing officer, accepted the evidence. Ms. Pearson testified that the exhibits had not been tampered with in any way. Mr. Michael Heier, hearing officer, accepted the evidence presented in front of the commission.
