III Purpose of Board

Responsibilities of the Board were discussed. The Board acts as an advisory board. They are to review life & health benefits, recommend changes and the Statute mandates a meeting every July.

Approval of Minutes of February 27, 2013 Meetings

Read February 27, 2013 minutes. Motion by Kenneth Krefft, seconded by Barry Blumberg, minutes accepted.

III New Business

Certificate of Recognition

Recognition of Mr. James Lee, past Chairman of the Board, who passed away in March, 2014. Ms. Patty McGee accepted a plaque on behalf of the Lee family.

Swearing in of Board members

Ms. Angela McCulloch, special counsel to the Board, swore in new Board members, Mr. DiMattia, Mr. Williams, Mr. McKnight, Mr. Harvey and reappointed and re-elected board members Mr. Blumberg and Mr. Krefft.

Board Elections

Board elections results were summarized by Ms. DeWitt. The election to fill the seat that represents the Department of Corrections employees had a tie.

A motion was made by Barry Blumberg, seconded by Melissa Lee, to hold a new election for the seat that represents the Department of Corrections. There being no objection the motion passed.

The election for the seat that represents Retired Teachers & other retired school employees received two applications. Neither application had the required qualified petition signatures to run for the seat. The Bylaws allows the Board to appoint Dr. Broussard for 2 years.

A motion was made by Rikki Nicole David, seconded by Ms. Lee, to appoint Dr. Broussard to the seat that represents Retired Teachers & Other Retired School Employees for two years. There being no objection the motion passed.

The election for the seat to represent Teachers and Other School Employees of Elementary & Secondary Schools did not receive any applicants. This seat can be appointed by the Board for a 2 year term or until the next regular scheduled election.

Lawsuit

Mr. Krefft requested the status of the class action lawsuit alleging OGB willingly overcharged PPO plan members who had medical procedures performed at outpatient surgery centers. Ms. Angela McCulloch reported that the lawsuit had been dismissed.

CEO Report

Ms. Susan West introduced herself, reviewed OGB's history and presented a powerpoint presentation (part of permanent file) to the Board regarding all of the changes to be implemented.

Ms. West reported that the key findings causing problems for the program are:

- Premium equivalent rates do not cover expected spending. OGB spends \$1.20 for each \$1.00 received.
- Program financial trend requires action
- At risk for the ACA Cadillac Tax effective 2018 40% tax on the plan \$31,000,000
- Plan design misaligned compared to state benchmarks
- Unrealized opportunities for health improvement for members with significant prevalent risk factors such as diabetes, smoking, and/or weight issues.
- · Organization's structure and resources misaligned.

She reported on the plan transformation with the following initiatives

- Plan Design Rebrand with New Program; New Plans with New Names
- Culture & Health Management Focus on preventative health and member well-being
- Plan Management/Controls
 - Adopt medical and pharmacy management controls
 - Adopt pharmacy formulary
 - Communicate to Medicare eligible the benefits of the Medicare exchange
- Reorganizing the OGB organizational structure to experience savings.
 - o Improving the website and paper communication to help the plan member

- Rate increases to the Program
- The Cadillac Tax effect on the Program
- The issues facing HR personnel for state agencies assuming task previously done by OGB.
- Will state agencies and state entities still be able to enter the OGB program?
- Plan available without a deductible.
- Where will retirees go for assistance in regards to enrollment and eligibility issues.
- Wellness checkup benefits and how they are handled.

She encouraged any assistance and partnerships with any association that could assist OGB with providing this information to all plan members.
