Approval of August 18, 2015 Minutes

On motion of Larry Tremblay, seconded by Edward Martin, the Executive Committee of the Health Works Commission voted to approve as amended the minutes of the August 18, 2015 meeting.

Review of Funding Proposals for FY 2015-16

At Chair Fontenot's request, Dr. Larry Tremblay reviewed the Health Works Funding memo of October 8, 2015 (Attachment A), that was sent to the Health Works Commission by Chair Laurie Fontenot. With the SMTEC-LA proposal revised to include faculty development only, Dr. Tremblay explained that the recommendation for consideration was to spread the funds so that each proposal received approximately ninety percent of their original requests. Dr. Sheila Chauvin commented that the \$2,000 reduction to the SMTEC-LA proposal would adversely affect their training efforts as the original proposal had been at the bare minimum. Ms. Lisa Deaton, speaking on behalf of the Louisiana Action Coalition, volunteered to reduce the LAC/LACANE proposal request by \$2,000 to assist.

On motion of Larry Tremblay, seconded by Edward Martin, the Executive Committee of the Health Works Commission voted to approve the following distribution of funds:

Dr. Tremblay indicated he would research some of the varying options discussed.

It was proposed that a Doodle poll would be circulated to decide on the date and time for the first quarter 2016 meeting of the Health Works Commission.

On motion of Larry Tremblay, seconded by Edward Martin, the Executive Committee of the Health Works Commission voted to adjourn the meeting. The meeting adjourned at 11:09 a.m.

RE:	Health Works Funding

At its meeting on August 18th, the Executive Committee, acting on behalf of the Commission in the absence of a Commission quorum, made funding recommendations for those proposals submitted for consideration for 2015-16. The requests totaled approximately \$276,000 and \$180,000 was available to support these proposals. The funding recommendations adopted by the Executive Committee at that meeting were as follows:

Following the meeting, as requested by the Executive Committee, Larry Tremblay contacted each sponsor to determine whether each wanted to accept the award at the recommended amount and, if so, to alter the proposal to reflect the recommended amount. All sponsors responded favorably. However, he was informed that due to job changes and related matters, the SMTEC-LA proposal would no longer be able to support the point-of-care aspect of the proposal. The Executive Committee had expressed some concern regarding use of higher education funding to support point-of-care training. Dr. Sheila Chauvin, chair of SMTEC-LA revised the proposal to scale it back solely to faculty development activities, primarily train-the-trainer workshops. The revised proposal will cost \$27,000, freeing up \$13,000 from the original recommendations for other uses.

Unfortunately (lessons learned), the Executive Committee did not provide any authorization to handle this situation; therefore, the Commission needs to reconvene to address the additional dollars available. As chair, I would like to recommend for the Health Works Commission's consideration the following distribution:
