At Chair Fontenot's request, Larry Tremblay distributed a handout (Attachment A) designed to initiate discussion regarding the seven Funding Proposals (Attachment B) for 2014-15 received by the Health Works Commission.

Following extensive discussion of each proposal and a series of options presented by Executive Committee members,

Joseph McCullouch moved and Edward Martin seconded the motion for the following distribution of funds: \$70,000 for SLCC/LACANE Tuition Reimbursement; \$95,000 for PoC SIM and SIM-Faculty Development; and \$35,000 for Minority DNP.

After further consideration, Dr. McCullough amended his motion to the following distribution of funds:

Joseph McCullouch moved and Edward Martin seconded the motion for the following distribution of funds: \$30,000 for the two Minority DNP proposals, to be coordinated by LAC, LSUHSC-NON and SUBR; \$100,000 for PoC SIM and SIM-Faculty Development (with a commitment for the development of the final four faculty development modules); and \$70,000 for SLCC/LACANE tuition reimbursement proposal.

The motion passed unanimously.

After a brief discussion regarding workforce, Dr. Tremblay proposed that at the next meeting, Dr. Cynthia Bienemy, Director of the Louisiana Center for Nursing, Louisiana State Board of Nursing, would report on nursing forecasting and workforce data. Dr. Bienemy agreed to do so.

Chair Fontenot initiated discussion regarding the next HWC meeting dates. It was decided to work to establish customary meeting dates, with the first Tuesday of the month at 1:30 p.m. being the first suggestion. A Doodle poll will be distributed to collect available dates and times.

There being no other business to come before the Executive Committee, Chair Fontenot adjourned the meeting at 3:30 p.m. on motion of Dr. McCullouch and seconded by Ms. Laurie Hinrichs.
