Consideration of the March 2, 2023, Integrated Criminal Justice Information System Policy Board Meeting Minutes

There was one revision to be made on the March 2, 2023 meeting minutes, adding a Mr. Neal Noel in attendance for Mr. Fabian Blache. Chairman Chief Justice Weimer called for a motion to be made to approve the March 2, 2023 Integrated Criminal Justice Information System Policy Board meeting minutes after correction. A motion was made by Mr. Daniels, seconded by Mr. Craft. There were no objections; the motion passed.

### 5. New Business

a. Discussion of 2023 Legislative session

Mr. Bacala mentioned the funding the board applied for did not get approved.

b. SEARCH Group, Inc.

Mr. David Roberts was the speaker on SEARCH, in place of Ms. Becki Goggins, whom was present but unable to present. SEARCH representative Mr. Michael Jacobson was present as well.

- i. Consultant scope of work/contract/deliverables
  - 1. Project period June 2023 March 2024
  - 2. Corrective Action Plan for improving arrest to disposition match rates
  - 3. Corrective Action Plan for improving submissions to the National Instant Criminal Background Check System (NICS) for firearms purchases
  - 4. Strategy for prioritizing and onboarding agencies with the capacity to submit dispositions to LASC and the state criminal history repository
  - 5. Draft information sharing governance agreement
  - 6. Technology assessments (including operational scenarios) for "as is" and "to be" information sharing environment
  - 7. Draft of a statewide information sharing strategic plan that includes the findings from working sessions with stakeholders

Mr. Roberts mentioned that a strategic plan takes about a year to a year and a half to develop, from gathering information from the committees.

Rep. Bacala suggested some authority be given for a sub-committee to be able to meet and take action more frequently. Mr. Roberts mentioned there would be communications and actions being discussed and taken in-between the meetings to move things along.

HB 560 (Zeringue)	Supplemental Appropriations providing funding for ICJIS (Initial appropriation - House \$10 mil, Senate \$5 mil)	Failed
HB 477 (Bacala)	Requires additional defendant demographic information be included with each Bill of Information or Indictment	Passed
SB 54 (Morris)	LEO may issue summons rather than arrest for certain felonies if LEO can ascertain that the person has no prior criminal convictions	Passed
SB111 (Duplessis)	Automatic expungements (new expungement procedure)	Passed (subject to appropriation)
