Mr. Blache presented the request to the Board members. Chief Martin made a motion to deny the request based on past precedence set by former LEEMI Board memberships. After some discussion, Chief Wilrye seconded the motion and the motion passed.

OTHER BUSINESS

Chief Anderson requested Mr. Blache to explain the process for requesting approval of training completed outside of conferences for continuing education hours credit. Mr. Blache informed the Board members and those in attendance of the required form, available on the LA Chiefs of Police Association's website. Mr. Blache stated that he would approve any requests for subject areas/courses that have been approved previously by the Board. Any subject areas/courses not previously approved by the Board would be sent to the Board for review and a decision. Chief Anderson stated that TASER training hours were denied by previous Board memberships and future requests for approval of TASER training hours would be denied. Mr. Craft expressed to the Board members and those in attendance that training hours outside of conferences that are submitted to the Board for consideration should be "executive level" training hours.

Chief Anderson informed the Board members and those in attendance of the Legislative Auditor's Report on Municipal Supplemental Pay was now available on their website, and he encouraged all Chiefs to review the report.
