Upcoming Events/Community Action

Dr. Monteic A. Sizer was asked to join a panel of statewide subject matter experts to discuss the state's Covid-19 response. There will be a specific focus on the disproportionate deaths happening in the African American community. Mistrust issues will be discussed as well within this population relative to Covid-19 vaccination. This event will take place on January 22, 2021, at 11:00 am.

Northeast Delta departments continue to develop plans for a phased, full reopening model where clients are seen face-to-face. All plans include universal precaution measures, technology, PPE gear, etc. Planning is being done following the Governor's recent phase 3 announcement. We have already secured many of the items needed to ensure the safety of staff and clients.

We were fully accredited by CARF. CARF will reevaluate for extended years in the coming months. CARF is the premier leader in certifying behavioral health and administrative excellence. We have also completed LDH's AIP clinical, administrative, and developmental disabilities audits. We scored 100% in almost every evaluated category.

We continue to participate in many social media campaigns, including suicide prevention and various addiction ones. We have also started a massive digital public awareness campaign about our programs and various services. This digital campaign includes Google, website, news banners, various social media outlets, etc. One commercial features our agency, and the other discusses opioids and what we are doing about it.

We continue to streamline agency contracts and program services to be more outcome- driven and more impactful with the resources available to us.

We are getting closer to outsourcing our pharmacy services as a cost saver with GEONOA Pharmacy. Again, we would maintain our current infrastructure. GEONOA would give us maximum flexibility and improve our services to regional clients.

We are partnering with LSU Ochsner Conway to administer Northeast Delta staff the Covid-19 Phizer vaccine. Additionally, we are planning to have our soon to be pharmacy offer the Covid-19 vaccine to Northeast Delta staff who prefer the Moderna vaccine. We will be offering the vaccine to our outpatient and inpatient clients. We will do the same for contractors as well.

QUARTERLY BOARD TRAINING - Behavioral Health

Northeast Delta Human Services Authority has hired 2 APRN's these positions will cover duties of four people without this certification.

The state is still in Phase 2 of COVID 19 due to an increase in infections and more deaths associated with the spread of the virus. The Governor is asking for people to continue to wear their masks to help stop the spread. PPE gear has been purchased to protect our staff when we can began to see clients face to face. We are now doing tele-psychiatry to be able to still service the client and keep our staff safe.

We are also working on finishing up the project of providing services from our mobile unit to provide treatment in the parishes we cover that need access to services and have no transportation.

We are getting closer to outsourcing our pharmacy services as a cost saver with GEONOA Pharmacy. Again, we would maintain our current infrastructure. GEONOA would give us maximum flexibility and improve our services to regional clients.

We are also working on opening a Children and Family Services office will be located @ 2525 Ferrand Street next door the Administration offices.

The CARF accreditation went well we are awaiting the results. We believe we will receive another three-year accreditation. CARF is a premier leader in certifying behavioral health and administrative excellence. We have received full three-year accreditations in the past.

Dr. Sizer has been asked to be a panel member for the COVID-19 VACCINES: A Conversation with the African American Community webinar that will take place on January 22, 2021 from 12pm – 1pm via ZOOM.

- 7. Look for ways to become even more efficient and effective at what we do.
