- Commerce will solicit public engagement on improving management and science related to Magnuson-Stevens, Endangered Species, and Marine Mammal Protection Act.
- Within 6 months, Regional Fishery Management Councils shall identify actions to reduce burdens and increase production. Councils will develop a work plan to achieve this.
- Commerce will request public engagement on fisheries management and science priorities for seafood supply chain.
- NOAA Fisheries shall use less expensive & more reliable technology for fisheries assessments. Additionally, NOAA Fisheries shall expand exempted fishing permits.

Al Sunseri stated that the oyster industry is impacted by imports, Korean and Canadian oysters have had an impact on LA business and Chinese oysters that supposedly come in cooked but since there are hardly any checks and balances there should be more testing going on, there is a labor issue, doing away with H2B visas might not be a good idea, need a labor system to get the type of labor necessary for this industry, farmers in CA special recognition for this type of thing may need to look into this for the oyster industry

Visioning the Future Workshop will have this in Spring of next year and will work with the Governor's office on this, hypoxia affects the oyster industry sometimes during the summer months August and September sometimes see die offs regularly, Brad Robin stated that the oyster industry would like to be looked at as a farmer so they can be insured, Sam Slavich mentioned closing Mardi Gras pass












Al Sunseri inquired about how long oysters can survive at the lowest salinity? Test condition is 2PPT, and a temp of 78-80 degrees F, just completed first round of validation, first low salinity oyster challenge 60% mortality on day 40-50 at these conditions, in most recent set parents were identified as having tolerant DNA, grew these up and these lasted a bit longer mortality didn't happen until around day 80 spawning second generation and will have data soon on this, \$14M for the first three years, basically looking at about \$20M total for the project

LDAF is working with LDH with seafood testing, had some labeling issues that were corrected, Representative Higgins co-authored a bill on farm-raised legislation, The Seafood Safety Task Force plans to host their next meeting on September 18th at 10am at Department of Ag headquarters



Recommended Regulations for Oyster Season Opening

- For seed bedding, greater than 15 percent of non-living reef material in bedding loads is prohibited. All vessels
 must allow on-board inspection and sampling of seed oyster loads by LDWF biologists and/or Enforcement agents.
- All vessels seed bedding on the open public oyster areas, seed grounds, or reservations shall not have sacks or
 other containers typically used to hold oysters on board the harvest vessel.
- A vessel is limited to either harvesting market oysters for direct sale (sacking) or harvesting seed oysters for bedding purposes on any one day and is specifically prohibited from doing both on the same day.
- Any individual actively harvesting oysters in the public oyster areas, seed grounds, or reservations designated as
 "closed" by LDH shall be properly permitted for such transplant/relaying by LDH in accordance with the state
 sanitary code.
- The possession limit shall not apply to vessels operating under a valid Oyster Cargo Vessel Permit, and these
 properly-permitted vessels shall not harvest oysters while operating under the cargo permit.
- All vessels located in public oyster areas, seed grounds, or reservations during those times between one-half hour after sunset and one-half hour before sunrise must have all oyster scrapers unshackled.




Additional Recommended Regulations for Oyster Season Reopening - Electronic Reporting Requirements

- Electronic Reporting will be done through an application by Shellcatch through your smart phone (available for Android & Apple)
- Every vessel harvesting oyster resource from the Public Oyster Areas shall report harvest information to the LDWF before 9 pm each day fished.
- Vessels shall provide the following information: Captain's name, oyster harvester number, vessel number, the total number of sacks harvested that day, total barrels of seed removed, and the public oyster area fished (LDH Harvest Area).
- The registration requires email or phone number, name, oyster harvester license number, and type of license to register. Once the account is created, a fisherman will add their vessels.



J. Eric Sunstorm provided a legislative update

Passed: Signed by Governor: HB 497 (Act. No 201) by Jeremy LaCombe→The proposed bill amends provisions of the Louisiana Catch and Cook Program to allow charter boat captains to directly provide fish to retail food establishments for preparation. It outlines requirements for packaging, labeling, and refrigeration of fish or alligator meat and mandates participation permits for establishments and captains. The bill also allows the Department of Wildlife and Fisheries to suspend or revoke permits for rule violations. Effective Date: 8-1-25. Last Action: 6-8-25. HR 36 (Enrolled) by Brett Geymann→The proposed bill approves the Fiscal Year 2026 annual state integrated coastal protection plan as adopted by the Coastal Protection and Restoration Authority Board. It affirms the board's responsibility to oversee coastal protection efforts and outlines public input requirements, funding priorities, and legislative review. The plan becomes effective upon legislative approval or by default if not disapproved by July 1, 2025. Effective Date: 6-4-25. Last Action: 6-4-25. SB 23 (Act. No 91) by Eddie Lambert→The proposed bill amends requirements for seafood dealer receipt forms in transactions with commercial fishermen. It mandates that dealers provide a copy of the signed receipt to the fisherman within 24 hours of the transaction, rather than immediately. Dealers must also record specified details—such as species, quantity, price, and licenses—on the form within 24 hours. The bill aims to clarify responsibilities and timing for accurate documentation. Effective Date: 8-1-25. Last Action: 6-8-25. Read full provisions here:

SB 94 (Act. No 105) by Mike Fesi Sr→The proposed bill redefines "waters of the state" to include the "Gulf of America" instead of the "Gulf of Mexico" and updates relevant statutes accordingly. It also clarifies definitions related to pollutant discharge, fastlands, and the state's coastal boundaries. The bill mandates terminology changes across Louisiana laws and confirms that these changes will not affect land or water ownership or access rights. Effective Date: 6-8-25. Last Action: 6-8-25. Desk: HB 548 (Enrolled) by Jeremy LaCombe→The proposed bill establishes how revenue from carbon dioxide sequestration on state-owned property, including land managed by state agencies, will be distributed. Thirty percent of injection-based revenue will go to affected parish governments, with the remainder directed to either the State General Fund or the Louisiana Wildlife and Fisheries Conservation Fund. It mandates reporting, defines revenue types, and preserves conditions of prior land donations accepted by the state before August 1, 2025. Effective Date: 8-1-25. Last Action: 6-10-25. It also modifies eligibility and fee structures for combination licenses for seniors and retired or honorably discharged military members. Eligible residents may obtain annual licenses for \$20, with documentation requirements clarified for proof of military service. The bill ensures support and access for qualified individuals. Failed to Pass (House): House Ways and Means: HB 149 (Voluntarily Deferred) by Marcus Bryant→The proposed bill makes licensed charter boat fishing guides eligible for existing state and local sales and use tax exemptions related to commercial fishing ventures. It retains current law for commercial fishermen and extends the same tax benefits to licensed guides. House Transportation: HB 301 (Substituted by HB 676) by Jessica Domangue→The proposed bill requires the Department of Wildlife and Fisheries to establish rules for handling abandoned vessels, including tagging by law enforcement, third-party recovery, owner information access, and procedures for obtaining salvage titles and selling recovered vessels. It mandates notification to registrants about ownership responsibility. The bill also requires the department to adopt rules for registering and titling vessels that are abandoned or lack proper documentation, aligning with existing law. Effective Date:

House Natural Resources and Environment: HB 550 (Substituted by HB 652) by Timothy Kerner→The proposed bill requires seafood processors and distributors to submit quarterly reports to the Department of Culture, Recreation and Tourism detailing the volume, species, and origin of seafood bought and sold. It also mandates that dealers applying for imported seafood licenses provide an annual detailed accounting to the Department of Wildlife and Fisheries. The departments are authorized to track this data and issue penalties for noncompliance. Effective Date: Failed to Pass. Last Action: 4-22-25. HB 604 (Voluntarily Deferred) by Joseph Orgeron→The proposed bill authorizes the Department of Wildlife and Fisheries and the wildlife and fisheries commission to create a red drum tag program. It allows for the issuance of tags permitting the harvest of red drum exceeding the 27-inch limit, provided population health is considered.
