Shane Bagala stated that they are having some issues in the back of Terrebonne Parish with gray areas, boats working around leases, told some of the land is dual ownership and the areas cannot be enforced due to it being dual claimed

Cole Garrett stated that in 2015 two bills that went through the legislature and one had a stipulation that if there were private leases that were recorded as of a certain date in 2015 then we would have to accept those as valid, can look into this with more information on the location



# **UPCOMING MASTER PLAN SCHEDULE**

Draft Plan Released January 6<sup>th</sup>; Public Comment Period January 6th through March25th; Public Hearings (4)-January 31st-February 16<sup>th</sup>; Revised Plan, incorporating public comments, presented to CPRA Board for approval-April 19<sup>th</sup>; Submit Draft Final Plan to Legislature following CPRA Board approval



CPRA is accepting comments on the annual and master plans at this time

B. The task force heard an update on possible 2023 oyster related legislative proposals

Cole Garrett stated that there are no plans at this time to have anything in the package to submit regarding oyster related legislation, will plan to keep the task force updated should something come up

C. The board discussed possible changes to the Damage Evaluation Board

Ralph Pausina, with the LA Oyster Dealers and Growers Association, stated that he has 2 requests- the Evaluation Board has not had a case in a long time but there is a case pending now and looking at the rules, regulations, policy, procedure and methodology and trying to make them current. The first thing would be in methodology that the marine biologists' use to establish the value of an oyster lease before and after a project. The two items in there are the current market value of a sack oyster (dockside value) of a sack of oysters and market value of a sack, would like to recommend \$80/ sack. Also element that needs to be updated is the cost to produce a sack, recommend \$15 as the cost to produce the sack. Spoke with attorney and would be much better to provide justification, asking the task force to come up with recommendations as to what will be a fair dockside value and price to produce that sack, ask that the TF put this to a committee and have it at the next meeting to make a recommendation for the Damage Review Board and copy the LODGA

The task force sent this item to the Public-Private Oyster Seed Grounds Committee for further discussion, consider maybe bringing in an economist to consider these numbers and what is fair; should plan to come back once a year to update the numbers in the future

Jack Isaacs stated that he would be glad to look at the numbers, the \$15 to produce a sack sounds low

The board has a case pending now, a request for arbitration was made by the lease holder, this was taken to a federal court, if the federal court does not take it the Damage Evaluation Board will hear it, where things will be arbitrated is something to consider, when the board meets everything is recorded all members must be present, the representative for the Oyster Task Force participated by Zoom so he was not considered present. The board goes into executive committee and then action is taken, there is no recording during executive session, requested that the task force correct the situation regarding their representation and participation on the Damage Review Board

Jakov Jurisic suggested reaching out to OTF member that serves as a representative on the Damage Evaluation Board and if he is not interested in participating, maybe establish an alternate if possible or nominate a new representative

D. Discussed non-resident gear license regulations

Willie Daisy stated that boats that are Louisiana boats with a resident license and a gear license/ permits were purchase by the boat owners and then some non-resident fishermen came on boats to work and were told by LDWF enforcement that they would need a non-resident gear license

Patrick Banks stated that under State law a gear license is transferable from one person to another, temporarily, as long as those people have the same residency status. Public Oyster Seed Ground Gear License, if the OTF wants to allow gear licenses to be transferable to anyone regardless of their residency status would need legislation for this

A gear license is for the individual and vessel seed ground permit is for the vessel

Willie Daisy stated that the gear license should be an extension of the permit

Willie Daisy motioned to combine licenses to make the Public Oyster Seed Ground gear license an extension of the vessel permit, 2<sup>nd</sup> by Sam Slavich. Motion carries.

Cole Garrett stated that he would be willing to draft legislation for the task force's review

E. The task force considered funding to sponsor the Chairman's Dinner at the 2023 Interstate Shellfish Sanitation Conference

Jakov Jurisic motioned to approve up to \$7,000 to support the Chairman's Dinner at the 2023 Interstate Shellfish Sanitation Conference, 2<sup>nd</sup> by Willie Daisy. Motion carries.
