Public Comment Wyclif Oguma, Occupational Therapist, from Kenya introduced himself and explained that he is in the U.S. for a 5-week fellowship program to learn about employment programs for youth with disabilities. His mentors are Sue Killam and Phil

Wilson with the LSU Human Development Center.

LRS Director's Reports Melissa Bayham, new LRS Director, introduced herself to the Council. She and members of her executive team will travel to the Regional Offices to meet with staff. LRS is in the process of hiring new rehabilitation counselors and associates to increase service capacity. Order of Selection (OOS) Group 3 opened on October 1, 2018, as a result of receiving additional state general funds from the legislature. LRS was also able to restore rates for books and small business development. After receiving more guidance from RSA on Pre-employment

Chair Report

LRC Executive Committee held a strategic planning session on October 11, 2018. Priorities for the year are: serving more consumers with the emphasis on quality; advocacy and education of the public as to what LRS does for the disabled citizens of LA; try to establish a plan on how to assist those consumers who do not fall into the "normal" course of assistance who may be falling through the cracks; and revamping of the assignments to the committees of the LRC. Assignments will be given to the subcommittees as the need arises.

Succeeds Act (ESSA) which is a new accountability measure for alternative schools. The LA DOE publishes current information in newsletters available on their website and by subscription.

SILC report- Lewis reported the SILC has 6 new members. The next SILC meeting will be the first week of the second month of the quarter. The SILC will hold 2 public hearings as part of the development of their next State Plan. The SILC is working collaboratively with stakeholders to accomplish SILC goals. Activities include a SILC/Rev Up Tour of the state to educate individuals with disabilities about independent living center services and voter registration. In October, National Disability Employment Awareness month, the SILC is putting together an Inclusion Job and resource fair in Baton Rouge on October 30.

<u>WIC report</u>- Lobos reported that the WIC will meet in December and a report will be provided at the January LRC meeting.

CAP report- Baker provided the report for Butler. CAP noted an increase in complaints that are misunderstandings between clients and LRS counselors and these can be easily resolved. CAP has seen an increase in clients wanting to pursue a college degree and told it is not a viable goal or clients are already gainfully employed. Also, an increase is noted in clients needing post-employment services. CAP has seen an increase in clients stating the vendors are not helping them to locate jobs as they should or matched to jobs that don't suit their abilities. CAP is addressing cases in which reasonable decisions have not been reached. CAP provided representation at one fair hearing and one administrative review. As part of outreach, CAP will have an information table at the SILC job fair. CAP is requesting to be included in LRS meetings regarding transition-related topics, issues, or planning.

New Business

Scurria expressed concerns regarding accessibility, such as bus routes, parking, building access, and privacy concerns with the LRS Baton Rouge Regional Office when it moves to the LWC main campus.
