Continuing, Mr. Cunningham encouraged the Board to come together, coordinate, and focus to make sure the reductions do not occur to higher education.

Mr. Vincent stated that the Donald Wade House is 100% completed, and a Dedication will be given in the month of March 2015.

Dr. Mason stated that an appeal has been filed with the NCAA regarding the post season ban for Athletics at Southern University - Baton Rouge.

Dr. Mason also informed the Board, that the National Initiative on black males that is called the Five Fifth Agenda for America, and the pilot, the Honore' Center at Southern University at New Orleans will receive \$500,000 dollars from the Ford Foundation and \$200,000 from a private donor.
