H. Approval of Personnel Action on Positions greater than \$60,000

1. Recommendations for Appointments of Deans and Director, SUBR (*Executive Session may be required*)

Upon the motion by Atty. Tony Clayton and seconded by Mr. Myron Lawson that the personnel actions be approved but not at the salary requested due to impending budget cuts;

Dr. Belton stated that a percentage of the CUPA average was used in calculating the salaries of Deans. Executive Vice President and Provost, Dr. M. Christopher Brown stated that the University could be in violation of several SACSCOC Standards if the appointments are not made to stabilize the academic units.

Board members expressed concern about Dr. Brown's presentation including the fact that the cost savings is not as much as he stated for merging the engineering dean and the sciences dean positions.

Dr. Brown explained that the calculations were first done at 85% of the CUPA average and in light of a possible mid-year budget cut the salaries were calculated at 75% of the average so that the current budget would support the salary recommendations.

Rev. Gant encouraged Board members to take action on the appointments so that the academic unit could be stabilized and a leader in place to effect change. He also stated that the search committees have completed their work.

Atty. Clayton withdrew his motion.

Atty. Magee stated that he would like to act on each of the personnel items individually.

8. Informational Items

A. NCAA Update

Interim Director of Athletics Roman Banks spoke about the recent NCAA ruling on infractions. He stated that due to a great staff and the outside consultant and years of probation and post season bans, the program is on the right track. The NCAA has confidence in the leadership of the institution and the program. The NCAA has imposed a 5-year plan to provide oversight to the programs. Banks commended Mr. Trayvean Scott of the athletics staff, for efforts with the APR and announced the projected APR numbers for all programs for the 2015-16 year.

Mrs. Ann Smith made a presentation to Mr. Myron Lawson on behalf of the LA Student Financial Assistance Commission. She stated that Mr. Lawson serves on the commission as a member of the SU Board.

B. Priority Projects Updates, SUS

Vice President McClinton stated that the priority projects were included in the meeting packet and on the Board's website. Mr. McClinton stated that Dr. Belton submitted a letter to Governor Edwards requesting assistance with the repair to B.A. Little Road. The Board of Regents has agreed to assist the University with the repair.

C. System President's Report

President-Chancellor Belton recognized Zana Harris SGA president and also recognized Board Member Calvin Braxton who will be honored by the National Black Caucus of Legislators during their 40th annual conference. He also thanked the Chancellor's search committee for SUNO and congratulated Dr. Lisa Mims-Devezin on her appointment.

D. Campus Reports

SUNO - Dr. Devezin thanked the Board members for their confidence in her as leader of the SUNO campus and reminded Board members of the Appreciation Brunch on Saturday morning and announced that SUNO has been selected as the Tom Joyner Foundation's School of the Month for the month of February 2017.

SUSLA - Chancellor Ellis stated that the report was included in the meeting packet.

SUAREC – Dr. Phills stated that the medical cannibas program is progressing and that information would be forthcoming about a town hall meeting that is being planned for the public in January. He also stated that the Request for Proposals (RFP) would be disseminated in February to solicit vendors.

SULC – Chancellor Pierre stated that the Kendall Vick Foundation has donated over \$600,000 to the SULC for students for financial support. Chancellor Pierre recognized Atty. Jerome Reso, partner in the Baldwin, Haspell, Burke and Mayer Law Firm of New Orleans. Also stated that the SULC received notification of their continuing accreditation by the ABA and that the SULC would be offering classes in downtown Baton Rouge beginning January 2017.

9. Other Business

Atty. Clayton recognized Sherman Copeland and applauded him for his years of support with the Louisiana Legislature.

Atty. Clayton also congratulated Dr. Leon R. Tarver for his service as chairman of the Board and said he would put forth a motion in support of Dr. Tarver as chairman emeritus at the next Board meeting.

Rev. Gant stated that he would like to make sure that the work of the Law Center would continue in the Shreveport area.
