AGENDA ITEM 5: CHAIRWOMAN'S REPORT

Atty. Dinvaut stated that her report would be deferred until the December 12, 2014 meeting of the Southern University Board of Supervisors.

Atty. Dinvaut took a point of personal privilege and introduced Mr. John Bell Edwards, a member of the Louisiana House of Representative. Representative Edwards stated that Southern University System is the only HBCU System in America and is very concerned that the \$1.2 billion dollar shortfall in the Louisiana budget will affect higher education. Representative Edwards also stated that he has worked with Drs. Mason and Ukpolo to keep SUNO open. Representative Edwards also encouraged the Board to reflect on the following:

- **1.** Legislative amendment to increase funding. A legislative amendment will be difficult because of lack of funding and respective legislators being open to providing increase funding.
- **2.** Representative Edwards suggested that SUBOS should consider that the legislature might be more acceptable to SUS implementing an action like the LSU consolidated model or is implementing efficiency procedures. He stated he will continue to support the SUS, SUBOS, and LBCU and wanted the record reflect he was wearing blue and gold.
