NRCS/OSWC Farm Bill Cooperative Agreement- Mr. Joey Breaux, Director, SSWCC

The Farm Bill reporting system closed February 11th and districts were able to enter their hours for January. Farm Bill totals for January were \$104,902. We want to encourage districts to continue to input their figures into the Farm Bill system even after they max out their Farm Bill allocation. The districts are making great strides and we hope they continue their progress.

NACD Annual Meeting Summary-Mr. Joey Breaux, Director, SSWCC/ Mr. Alan Williams, LACD President Mr. Breaux said the virtual NACD Annual meeting took place on February 1-10, 2021. He said this was an informative meeting with great presenters. Chairman Girouard said NACD plans to use some of the presentations for training purposes. He said he attended the South Central Regional virtual meeting and they voted to move him to 1st Vice President. Louisiana contributed 6 items to the NACD auction. The Louisiana items went for more than their starting price and LACD was able to raise \$1,000. Mr. Williams said there were more than 1,800 people registered for the virtual meeting and he wanted to thank Calcasieu SWCD for donating 3 very nice items for Louisiana.

If a district board has more than 1 candidate interested in the vacant elected position, the board must hold an election on Saturday, June 12, 2021. All districts are also asked to email their election notices with locations to OSWC before April 1, 2021 which is the start of the nominating period. All supervisors who have no opposition will be duly elected at the SSWCC meeting in June. NRCS State Conservationist Report- Mr. Chad Kacir, State Conservationist

Mr. Kacir said FY 2021 CSP Classic signups will be open until March 31, 2021. Applications will be accepted throughout the year but producers should keep the deadline in mind to ensure that their applications are considered for funding. There has not been any clear numbers on the damages from the Winter Storm. NRCS is aware of a few partial and fully collapsed poultry houses in North Central Louisiana. He said FSA is attempting to organize an emergency weather meeting to handle assessments.
