**CALL TO ORDER**

The meeting was called to order by Mr. Parker at 9:32 a.m.

**Motion:** Mr. Parker made a motion to approve the labels for Elusion 2 SC, Talak 7.9 and Ternate SC for termiticide use and add to the Potpourri. The motion was seconded by Dr. Ashbrook and passed unanimously.

**Motion:** Mr. Parker made a motion for the label Notion 2 SC to be updated with statement “not approved for use in Louisiana” to the EP/LI section of the label. The motion was seconded by Dr. Rankins and passed unanimously.
