4	I would like to call this meeting to order. I am Bry
5	Layrisson. This is September 1, 2011. It is 10:02 a.m., and
6	we're going to have the Supplemental Pay Board meeting.
7	APPROVAL OF MINUTES OF JUNE 16, 2011 MEETING
8	MR. LAYRISSON:
9	The first item on the agenda is approval of the minutes
10	from the June 16th meeting.
11	MS. LEBOEUF:
12	I'll make a motion to approve the minutes.
13	MR. LAYRISSON:
14	I have a motion. Do I have a second?
15	MS. HUTCHINSON:
16	I'll second it.
17	MR. LAYRISSON:
18	I have a motion and a second.
19	Any opposed?
20	(No response.)
21	MR. LAYRISSON:
22	All right.
23	OLD BUSINESS
24	Gretna Police Department - Christopher Tapie
25	MR. LAYRISSON:

1	We'll go on to old business, Gretna Police Department.
2	MR. SCHEXNAYDER:
3	We still haven't heard anything from the AG's Office.
4	MR. LAYRISSON:
5	All right.
6	Henderson Police Department - Dustin Landreneau
7	MR. LAYRISSON:
8	Henderson Police Department.
9	MS. ROBERTS:
10	Basically, the documents all of the information has
11	been submitted to the Inspector General's Office. As of right
12	now, we gave them all the information they've asked of us, so
13	I'm assuming they are still in the investigation of that.

15	Okay.
16	NEW BUSINESS
17	Ball Police Department - Russell George
18	MR. LAYRISSON:
19	Next, on to new business, Ball Police Department, Russell
20	George.
21	MS. ROBERTS:
22	Mr. George is an individual that was getting supplemental
23	pay and has been with Port Allen, and then he transferred to
24	Ball, Louisiana. He had been in an accident prior to them
25	getting his supplemental pay paperwork sent into me, but

1	they've sent me the minutes and everything because I am
2	dealing with Workers Comp, I think, called me. They are
3	trying to settle this, because he was injured while I mean,
4	he was killed while working. So all I need is to be able to
5	pay him for the five days he was able to work, but I didn't
6	have an app, because, like I said, he wasn't there long enough
7	for them to get everything before the accident happened.
8	MR. LAYRISSON:
9	I make a motion that we submit the payment for the five
10	days of supplemental pay that he is was owed.
11	MS. HUTCHINSON:
12	I'll second.
13	MR. LAYRISSON:
1.4	Any opposed?
15	(No response.)
16	Basile Police Department - Darcy Watts
17	MR. LAYRISSON:
18	We'll move on to the Darcy Watts.
19	MS. ROBERTS:
20	Ms. Watts is a juvenile DARE officer, and I'm just trying
21	to make sure that this is an eligible position to get
22	supplemental pay, so
23	MR. LAYRISSON:
24	I believe I saw in the packet that she is P.O.S.T.
25	certified?

1 MS. ROBERTS: 2 Yes. 3 MS. HUTCHINSON: And we don't have any other DARE officers that are --4 MS. ROBERTS: 5 6 I don't know. See, I don't really -- I feel like we 7 might have some that are already getting it. I'm thinking 8 from the past, but I wasn't sure. I just got this in while I 9 was looking through them, and I don't -- I don't know. 10 mean, I could research it, if you all want to defer on it. can research it and see if we have --11 12 MR. LAYRISSON: 13 I think it's kind of similar to the situation that we 14 faced in Hammond, and in my opinion, as long as they are a 15 full-time police officer and they are P.O.S.T. certified, 16 their title or their job doesn't matter, so I believe that she 17 is eligible, unless our attorney sees otherwise. MR. SCHEXNAYDER: 18 19 There is nothing really -- I went through the law. 20 is nothing really on point that I could find that I could say 21 one way or the other. As long as she is acting as a police 22 officer and has to go make arrests and --23 MS. HUTCHINSON: 24 I think she is eligible.

16	I just brought it. If there is a title question, then I
17	like to bring it before the Board.
18	MR. LAYRISSON:
19	As far as I know, the school resources officers and the
20	DARE officers, and all that are getting it, as well.
21	MS. ROBERTS:
22	Right.
23	MR. LAYRISSON:
24	It goes back to if they are P.O.S.T. certified and if
25	they have arrest powers, we have to pay them.

4	submitted for approval.
