LAYRISSON: 4 5 The next item on the agenda is under old Okav. 6 business, Maringouin Police Department, John Simien. 7 At this time, I would ask that Mr. Simien, if you 8 would like to state your appeal to the Board, your 9 reasoning for --10 MR. SIMIEN: 11 Okay. I received a letter on September last year 12 stating that I would no longer receive the benefits, and 13 they were telling me why. It was confusing to me with the 14 letter I received in 2007. I understood about working law 15 enforcement, but when it got to the paragraph where it 16 says, however, since you are currently the chief of 17 police, you are exempt from the above. It is your action 18 whether or not you attend an academy, and that is what I 19 was questioning. 20 MR. LAYRISSON: 21 The Board -- our attorney, Mr. Paul 22 Schexnayder, is out today. The Board is going to review 23 your case once again. We're going to have our attorney 24 review it and check all of the records and the current

determines that you are eligible, you will receive back 1 2 If he determines that you're not eligible, then he 3 will state as to why. MS. GIROIR: 4 Chief, I'm representing the Office of Legal Affairs 5 6 today. 7 I understand what you're saying, and I've read that 8 letter that you got from P.O.S.T., and I think what the Board relied on is, they probably agree with that letter, 9 10 to serve as the chief of police, you do not have to be P.O.S.T. certified, but there are different qualifications 11 12 for receiving supplemental pay, and if one of those 13 qualifications is you have to be P.O.S.T. certified, then 14 you don't qualify for the supplemental pay. So there are 15 two different issues, can you serve as the chief of police 16 without being P.O.S.T. certified, and can you collect 17 supplemental pay. 18 So the law that is going to control for the 19 supplemental pay issue is the supplemental pay law. 20 MR. BLANCHE: 21 Okay. I was confused also, and when I read this, I 22 said, basically, what they're saying is, you're grandfathered in, and as the chief of police, then you are 23 24 exempt, and then what you just said is --

1 There are separate qualifications, one is to 2 actually be the chief of police, and --3 MR. BLANCHE: 4 The letter from P.O.S.T. is not explicit. MS. GIROIR: 5 6 From P.O.S.T., because P.O.S.T. doesn't make a 7 decision on supplemental pay. 8 MR. BLANCHE: 9 I understand that. No. 10 MS. GIROIR: So it's this Board's obligation to make a 11 12 determination of the individual -- the applicant's 13 qualifications for supplemental pay versus the 14 qualifications to serve in the position, so that is what 15 the Board will look at is the qualifications of an 16 individual to being eligible for -- to collect 17 supplemental pay as a chief of police, and I think, you 18 know, the Board will take all that information under 19 advisement, consider the law and your position, and issue 20 a decision to you. 21 MR. You go by the P.O.S.T. date at that point. 1 she got it within the year, she would start as of her 2 P.O.S.T. date. 3 4 MS. LEBOEUF: On her P.O.S.T. date, yes. 5 6 MS. HUTCHINSON: 7 Well, I'll make a motion to approve. MS. LEBOEUF: 8 Do you want to approve her, or do you want more 9 information? She put the wrong date, period. 10 MS. HUTCHINSON: 11 Yes, but you all just said that her P.O.S.T. 12 13 MS. GIROIR: Well, if she was working since 2012, that year would 14 have qualified her. 15 16 MS. LEBOEUF: So she's effective the P.O.S.T. date. 17 Oh, true. 18 MR. LAYRISSON: Why don't you just approve her pending verification? 19 20 MS. LEBOEUF: Yes, we'll do that. 21 22 MS. HUTCHINSON: I'll make a motion to approve pending verification of 23 24 her start date.

police duties, does he have 50 percent as direct law 1 2 enforcement? MR. LAYRISSON: 3 4 In my opinion, we should send this one to Paul for review. 5 6 MS. HUTCHINSON: 7 I agree. 8 MS. LEBOEUF: 9 I agree. 10 Tribal Area Police Officers 11 MR. LAYRISSON: 12 The next item on the agenda is the Tribal Area Police 13 Officers. 14 MS.
