Meeting of February 9, 2017

The regular meeting of the Second Injury Board convened at 2:04 p.m.

Mr. Hansberry called the meeting to order and began with *Item 1* on the agenda, being the reading of the minutes from the previous meeting. The Chairman moved to *Item 5* on the agenda, being the recommendation to approve reimbursement of (260) partial payments beginning with Claim #81-0040 and ending with Claim #15-0371. The Chairman asked for a motion to accept the recommendation and approve reimbursement of the partial payments as submitted on the agenda of February 9, 2017. The motion was made by Ms. Mack seconded by Director Kellar, and passed unanimously.

The Chairman moved to *Item 6* on the agenda, being the recommendation to approve (97) quarterly payments due beginning with Claim #88-0220 and ending with Claim #15-0062. Ms. Mack moved to accept the recommendation of staff and approve reimbursement of quarterly payments as submitted on the agenda of February 9, 2017. The Chairman moved to *Item 7*, Public Comment. No one from the public was present and the Chairman moved to *Item 8* on the agenda, Executive Session. Director Kellar made a motion to go into Executive Session to discuss Second Injury Board litigation and settlements. Ms. Mack seconded the motion and it passed unanimously.

Upon returning from Executive Session, the Chairman moved to *Item 8a* of the agenda, being settlement recommendations. Director Kellar moved to accept the recommendation. It was seconded by Ms. Mack and passed unanimously.

The Chairman moved to *Item 8b* of the agenda, being Second Injury Board litigation. The Chairman asked for a motions to grant authority to legal counsel to represent the Board as discussed in Executive Session. Motions and seconds were made in the following manner and passed unanimously:

The Chairman then moved to *Item 9* asking if there were any other matters requiring attention. Director Kellar made a motion to expand the agenda to discuss hearings. The motion was seconded by Ms. Mack and passed unanimously. Director Kellar briefly explained the issue of attorneys routinely requesting hearings before the Board and requested a discussion, opinion, and decision of whether or not the Board is required to grant a hearing under the statute. Mrs. Trahant read from a First Circuit decision, in which this issue was won on appeal. The case affirms the statutory language which states the board has discretion concerning whether or not to grant requests for hearings (see attached). Mrs. Williams gave a history of the problematic issue that included reasons why staff felt the requests were being used to circumvent submitting information required by the statute. She also mentioned the trend that was appearing of requests for hearings that included requests for subpoenas to be issued.

Mrs. Williams's opinion is that it's the Board's discretion to grant requests for hearings. Director Kellar requested the reading of 1378(C) (see attached) to which Mrs. Trahant obliged. Director Kellar made a motion that 1) requests staff creates rules for the Board's consideration and 2) the Board issue a policy to staff regarding the handling of requests for hearings in that they are presented to the Board at the meeting following the request. The motion was seconded by Ms. Mack and passed unanimously.

The Chairman then asked if there was any other business to discuss. Mr. Coulter questioned the practice of mediating claims and wondered if it could benefit the Fund. Mrs. Williams explained the conflicts that come into play regarding setting and reporting of reserves. After some discussion the Chairman asked again if there were any other matters needing to be brought before the Board. There being no further business to discuss, the Chairman asked for a motion to adjourn. Ms. Mack moved to adjourn. The motion was seconded by Director Kellar and passed unanimously.
