In 2008 he develop heart problems, he had to have heart surgery. In 2009 he was involved in an automobile accident he continued to work after the accident (see attached). Ms. Sumrall states that the only issue in dispute is the merger issue. Ms. Sumrall states that it's normally our practice that we request merger from a treating physician (see attached). The Chairman asked what's the pleasure of the board, Mr. Hawkland motion to postpone the decision for 60 days to allow time to Mr. Kern to get documents needed for this claim. The motion was seconded by Mr. Hataway and passed unanimously.

The Chairman moved to the next hearing. Claim # 14-0293 the employee is Rebecca Wagaman, the employer is Salvage Store, Inc. and the carrier is Louisiana Construction & Industry. Mr. Kern states Ms. Wagaman she stock refrigerators at the salvage store she injured her back and a fall. She was put as a cashier where she would not be lifting items that she would be lifting in the cooler. She requested to be put back to stock and she wouldn't lift anything heavy. She eventually lifts something heavy and causes her to reinjure her back (see attached). They are not able to get prior medical history because she signed a medical authorization (see
