Meeting of July 11, 2019

The Chairman moved to *Item 5* on the agenda, being the recommendation to approve reimbursement of (286) partial payments beginning with Claim #83-0072 and ending with Claim #17-0528. The Chairman asked for a motion to accept the recommendation and approve reimbursement of the partial payments as submitted on the agenda of July 11, 2019. Mr. Hawkland made the motion. Ms. Mack seconded the motion and it passed unanimously.

The Chairman moved to *Item 6* on the agenda, being the recommendation to approve (51) quarterly payments due beginning with Claim #95-0317 and ending with Claim #16-0709. Ms. Mack

moved to accept the recommendation of staff and approve reimbursement of quarterly payments as submitted on the agenda of July 11, 2019. Mr. Coulter seconded the motion and it passed unanimously.

The Chairman moved to *Item 7*, Public Comment. Representatives from LA Rehabilitation Services were present but no other members of the public. The Chairman made a request to amend the agenda to allow for the LRS Presentation. With no opposition, Mr. Chris Anthony and Dr. John Schweitzer gave a brief historical summary of the relationship between the SIF and LRS and updated the Board with the current number of successful cases. Handouts given to the members contained statistical information for FY 2019. This year, there were 808 employees served and it was the most successful year since FY 2015. After a short question and answer session, the Chairman thanked the representatives for their presentation. He then moved to the next item on the agenda.

Mr. Hansberry asked for a motion to go into Executive Session to discuss Second Injury Board litigation and settlements. Ms. Mack made the motion. Mr. Hawkland seconded the motion and it passed unanimously.

Upon returning from Executive Session, the Chairman moved to *Item 8a* of the agenda, being settlement recommendations. The Chairman then requested a motion to approve the recommendations of the Director regarding settlement authority as discussed in Executive Session and to extend settlement authority to be reimbursed on a quarterly basis for the following (10) claims.

Mr. Coulter made the motion. Mr. Hawkland seconded the motion and it passed unanimously.

The Chairman moved to *Item 9*, any other matters to discuss, which listed the Election of Chairman and Vice-Chairman. Meridith Trahan summarized the statute requiring the election. Mr. Hawkland nominated Mr. Charles Hansberry as Chairman; the motion, made by Mr. Hawkland and seconded by Mr. Coulter, passed unanimously. Mr. Coulter nominated Mr. Steve Hawkland as Vice-Chairman. The motion, made by Mr. Coulter and seconded by Ms. Mack, passed unanimously.

Mr. Hansberry again asked if there were any other matters to discuss being the second item under the section, the LRS presentation, was previously heard by the Board. Ms. Trahant stated she plans to present her recommendation of the percentage/amount of funds for the LRS allocation at the meeting in August. Additional discussion took place regarding the LRS/SIF relationship.

Mr. Coulter inquired on the availability of a board member attending a meeting by phone conference. Ms. Trahan stated that the agency determined it would not by wise and did not allow that option, nor was the equipment needed available.

Mr. Schroder questioned the level of oversight the Board has on the Fund's budget and expenditures. Ms. Trahant responded. After some discussion, the matter concluded.

There were then no other matters to discuss. The Chairman asked for a motion to adjourn. Mr. Coulter moved to adjourn. Ms. Mack seconded the motion and it passed unanimously.
