## LA WORKERS' COMPENSATION SECOND INJURY BOARD

Meeting of May 3, 2014

The regular meeting of the Second Injury Board convened at 2:02 p.m.

Mr. Hansberry asks the pleasure of the board. Mr. Hawkland moved that the board deny the request. Mr. Hataway second and passed unanimously.

Second hearing on the board claim # 13-0482 employee Stacy Boudreaux, the employer is Care Ambulance Service, Inc and the carrier is Louisiana Construction & Industry SIF. The representative for this claim is Mr. Gary Kern and Mr. Kirk Landry. Mr. Kern states that Care Ambulance was sold to Acadian Ambulance, the employee completed a second injury fund form when hired (see attached). Mrs. Sumrall states that the dispute is because a past existing condition and we do not consider it as permanent disability (see attached) Mr. Hansberry asks the pleasure of the board. Mr. Hawkland moved that the claim denied, Mr. Hataway second and passed unanimously.
