Meeting of November 13, 2014

The regular meeting of the Second Injury Board convened at 2:04 p.m.

Mr. Hansberry, Chairman, called the meeting to order and began with *Item 1* on the agenda, being the reading of the minutes from the previous meeting. Mr. Hawkland moved to dispense with the reading of the minutes and approve the minutes as printed and distributed. The motion was seconded by Ms. Pierce and passed unanimously.

The Chairman moved to *Item 2* on the agenda for hearings, Hearing #1 Claim #13-0425 has been postponed. Chairman moved to hearing #2 Claim #13-0664 the employee is Rodger Ferchaud, employer is J. H. Walker Trucking, Inc. and the carrier is Louisiana Construction & Industry – SIF. Representing Risk Savers Gary Kern speaks on behalf (see attached). Mrs. Williams argues that none of the conditions that were listed was presume permanent partial disability (see attached). Mr. Landry stated that Mr. Wright has an affidavit indicating that he has the power to hire and fire, he also speaks regarding the merger (see attached). Mrs. Williams states that in her opinion a permanent partial disability hasn't been established, she recommends to the board that this claim is denied. Ms. Joann request clarification regarding the questionnaire form (see attached). Mr. Hansberry asked for the permanence to be explained to him regarding the letter was giving out from Mr. Kern (see attached). Mr. Kern addresses Mr. Hansberry question (see attached). Mr. Hansberry ask the pleasure of the board, Mr. Hataway states that this claim isn't black and white it has a lot of grey area (see attached). Mr. Hataway motion to deny, the motion was seconded by Mr. Hawkland and passed unanimously. The Chairman moved to hearing #3 Claim #13-0838, employee Terry Bell, employer R & R Wood Products, carrier Louisiana Construction & Industry – SIF. Mr. Landry representing this case states that Terry Bell has been treated for a number of years for COPD (Chronic Obstructive Pulmonary Disease). Mr. Landry states that he has all proper documents to support his claim that it presumes permanent partial disability. SIB doesn't have a diagnosis of COPD prior to the accident. She states that he was treated for numerous respiratory issues but there's no diagnosis stating it (see attached). Mr. Hataway asked what the record that he had indicating he had COPD. Mr. Landry states it's a doctor report dated November 14, 2012 and the date of the accident is October 2012 (see attached). Mr. Hataway motion that this matter continues in executive session, and seconded by Ms. Pierce and passed unanimously

Next the Chairman moved to *Item 3* need to amend the agenda, add *Item #51* under *Item #4*, which will make Item #3 having items 1 through 11 recommended for payment Claim #14-0171. The Chairman moved to *Item 8b* of the agenda, being Second Injury Board litigation. The Chairman

Mr. Hataway moved to accept the recommendation. The motion was seconded by Mr. Hawkland and passed

Mrs. Williams discuss the approval for the 2014 Second Injury Fund annual assessment rate to be set at

5.75% which is the same rate as the 2009, 2010, 2011 and 2013 assessments. The 2012 assessment rate ticked

up slightly to 5.90% due to lower than anticipated benefits reported. (See attached). The request from the

Second Injury Board to approve the recommended assess of \$50,548,328.52, which reflects a rate of 5.75%.

There being no further business to discuss, the Chairman asked for a motion to adjourn. Mr. Hataway moved to

accept the recommendation. The motion was seconded by Mr. Hawkland and passed unanimously.

The meeting was adjourned at 3:27 p.m.
