Meeting of October 1, 2020

The regular meeting of the Second Injury Board convened at 2:08 p.m.

Mr. Lee made note that the Board was holding the meeting through video/teleconference pursuant to John Bel Edwards' Executive Order #84-2020, Section 2c.

Mr. Hansberry called the meeting to order and began with *Item 1* on the agenda, being the reading of the minutes from the previous meeting of September 3, 2020. Mr. Hansberry asked for motion to dispense with the reading of the minutes and approve the minutes as printed and distributed. The motion was made by Mr. Hawkland, seconded by Mr. Coulter, and passed unanimously.

Mr. Hansberry moved to *Item 2* on the agenda, Hearing Requests. There were three hearings listed.

Mr. Lee presented Claim #20-0162 to the Board, and stated that staff did not receive medical reports to support the elements of a PPD, nor subsequent injury. Additionally, information for knowledge was defective/insufficient and staff did not receive documents to support merger. He recommended the hearing request

be denied. Mr. Hawkland moved to deny the request. Ms. Faber seconded the motion and it passed unanimously.
