LA WORKERS' COMPENSATION SECOND INJURY BOARD

Meeting of October 3, 2013

The regular meeting of the Second Injury Board convened at 2:00 p.m.

Mr. White, Chairman, called the meeting to order and began with *Item 1* on the agenda, being the reading of the minutes from the previous meeting. Mr. Hawkland moved to dispense with the reading of the minutes and approve the minutes as printed and distributed. The motion was seconded by Ms. Mack and passed unanimously.

The Chairman then asked for a motion to move Item 7, Public Comment, to be the next item discussed. Ms. Mack made the motion. Mr. Hawkland seconded the motion and it was passed unanimously.

Mr. Gary Gamble, Ms. Jennifer Willis, and Ms. Jennifer Sullivan were present to discuss their position regarding settlement of Claim #08-0837. Mr. Gamble, legal counsel for the employee, presented a description of the employee's current medical condition and his evaluation of future medical costs. Ms. Willis commented on the financial burden the employee's family is undergoing. Ms. Sullivan then spoke on the conditions of the settlement reimbursement that would be required should the Board approve authority. Mr. White thanked the parties for presenting their views of the claim and stated a decision would not be made in Public Comment.

The Chairman moved to *Item 2* on the agenda, being hearings on pending claims on the October 3, 2013 agenda.

Hearing # 1 Claim # 12-0545; Employer: Synergy Care, Inc. and Carrier: Bridgefield Casualty Insurance Company. Mr. Dominic Amato and Ms. Gina Cursain were present representing the carrier. Mr. Amato gave a description of the employee's medical conditions. He then stated his opinions of why the claim should be approved for reimbursement using specific medical reports. Ms. Michelle Sumrall, SIB Compliance Officer Supervisor addressed the previous accident and 1007 report along with disputing information included in the claimant's medical records. After final comments by the parties present, the recommendation of Ms. Sumrall was that the claim be denied. Mr. Hawkland made a motion for denial. The motion was seconded by Ms. Mack and passed unanimously.

Hearing # 2 Claim # 12-0875; Employer: Monroe City School Board and Carrier: Monroe City School Board. No one was present to represent carrier. Ms. Michelle Sumrall, SIB Program Compliance Officer Supervisor, stated the required information was received prior to the meeting and recommended that the claim be approved for reimbursement. Mr. Hawkland made a motion to accept the recommendation that the claim be approved. The motion was seconded by Ms. Mack and passed unanimously.
