- Jawanda Givens read a portion of the La. R.S. 42:17.1 Certification:
  - On March 11, 2020, in Executive Proclamation 25 JBE 2020, Governor John Bel Edwards declared a state of emergency for Louisiana due to COVID-19. The state of emergency was extended in subsequent Executive Proclamations with the most recent extension in 235 JBE 2021 on December 22, 2021. The state of emergency is a public health one and an in-person meeting of the WIC hosted at the Louisiana Workforce Commission would be detrimental to the health, safety, or welfare of the public.
  - In accordance with Louisiana Revised Statute 42:17.1, the presiding officer of the WIC, Meridith J. Trahant, hereby certifies that the agenda of the meeting is limited to 1) matters that, if they are delayed, will cause curtailment of vital public services or severe economic dislocation and hardship and 2) matters that are critical to continuation of business of the Louisiana Workforce Commission and are not able to be postponed due to other deadlines that cannot be postponed or delayed.
  - As such, in accordance with Louisiana Revised Statute 42:17.1, the WIC meeting on Tuesday, January 18, 2022 at 9:30 AM will be held by video conference and in a manner that allows for observation and input by members of the public in accordance with the provisions of the Louisiana Open Meetings law.

# VI. Presentation from Department of Children & Family Services (DCFS) Presenter: Lorrie Briggs, Deputy Assistant Secretary of DCFS

- Kellie Taylor-White explains that WIC is responsible for coordinating all workforce programs throughout the state. We want to make these presentations so we highlight all the efforts being made in workforce development around the state.
- Assistant Secretary Tavares Walker invites collaboration with the agency.
- Secretary Ava Cates remarks one of the issues we had was reimbursement because of the bureaucracy between state agencies. It was beneficial to locals to coordinate and have a DCFS person on local boards. We had to learn when to partner and get out of our own way. Louisiana can now draw down more federal money when there is a state match.

#### VII. Other Business

- a. Secretary Cates mentions that a huge issue this session will be replenishment of the state trust fund. For our business members on the call, it will be a major issue. There is \$230 million in the fund currently. There has been an infusion from the first round of CARES/ARP funding, but we are working hard to ensure we get back up to \$750 million mark so there will not be an increase in tax on businesses.
