Item 3 was considered in globo. Mr Bennett moved approval, seconded by Ms. Hutchinson that Ms. Guilbeau as Support Staff of the DSSP Board would request payment for the deputies submitted.

Ms. Guilbeau provided the Request for Reconsideration for DSSP Eligibility of Deputy Darryl Derosin from Pointe Coupee Parish Sheriff's Office for Item 4. After discussion it was motioned by Ms. Hutchinson and seconded by Mr. Bennett that Deputy Derosin is ineligible to receive supplemental pay. Eligibility requirements for the program stipulate a deputy sheriff must complete one-year full-time service, and the prior service with LA Department of Justice does not qualify per R.S. 40:1667.1(B)(1). Deputy Darosin has had greater than a five-year break in service, and the deputy must wait one year before being eligible to receive Deputy Sheriff's supplemental pay.
