Items 3.A to 3.V were considered in globo. Ms. Hutchinson moved approval, seconded by Mr. Bennett, and without objection, the items were approved to be recommended to JLCB for final approval of back supplemental pay totaling \$37,198.98.

Ms. Guilbeau discussed Calcasieu's change in job duties for Mark Rosteet as a Training Academy Instructor. After discussion among the board members, Mr. Bennett moved to defer this item, seconded by Ms. Hutchinson. Each board member will ask their legal staff about the direct law enforcement requirement and if a Training Instructor would qualify under the requirement.

Ms. Guilbeau discussed Ouachita's addition of a Training Deputy. The question is if a training deputy qualifies for supplemental pay with the direct law enforcement requirement. After discussion among the board members, Mr. Bennett moved to defer this item, seconded by Ms. Hutchinson. Each board member will ask their legal staff about the direct law enforcement requirement and if a Training Instructor would qualify under the requirement.

Ms. Schexnayder discussed the implementation of the new DSSP on line system. Ms. Schexnayder advised our office will get a new deputy listing from each parish and train the parishes. Mr. Bennett advised LSA can assist in getting the new DSSP system notification to the parishes. Ms. Guilbeau demonstrated the new DSSP on line system from the clerk's role.

Ms. Guilbeau advised that the previous updates to the manual that were reviewed by the board will be uploaded to the Treasury's internet site.
