II. APPROVAL OF MINUTES

A motion was made by Mr. James Stein, seconded by Mr. Frank Minvielle approving payment of Invoices #212414, #2122427, #212474, and #212531 in the total amount of \$3082.50 to Berard, Habetz, and Associates.

Guest Speaker - Mr. Reggie Dupre, Director of the Terrebonne В. Levee & Conservation District.

Mr. Ben Langlinais introduced Mr. Reggie Dupre, Executive Director of the Terrebonne Levee & Conservation District, to share his experiences and knowledgeable information in regards to Levee Districts. Mr. Dupre welcomed Mr. Mitch Marmande and Mr. Oneil Malbrough to join the conversation.

Mr. Dupre explained that due to the 2006 Levee District Reform Amendment, all Levee Districts lost their funding source. Prior to 2006 all Levee Districts had a 5 mill constitutional operation and maintenance millage. He provided a history briefing on the endeavors of Terrebonne Levee District and advised that if you want Capital Outlay funding on larger scale projects, you must be willing to match some of your own money. He further provided information on his District's experiences that would benefit the Iberia Levee District in its efforts. He invited the District to a

informal yearly meeting where his District and surrounding Levee District's gather in either June or July, in order to compare notes and learn from each others endeavors.

C. Update on the State Master Plan and South Central Study.

Chairman Gonsoulin stated that he along with other individuals met with Mr. Ricky Brouilette and Mr. Norwyn Johnson in regards to the Master Plan and South Central Study. Mr. Berard stated that over \$1 million of funding has been appropriated to conduct studies in this area. Mr. Thibodeaux elaborated that it appears they are trying to move forward to best use the funds with priority projects.

Mr. Thibodeaux reminded the District that Capital Outlay requests are due by November 1, 2012. Chairman Gonsoulin requested that Mr. Marc Berard obtain such information from Mr. Thibodeaux.

D. Report on presentations given to Organizational Clubs.

Chairman Gonsoulin stated that all meetings went excellent. He noted that the Optimist Club presented several questions in regards to the Loreauville and T-Bayou areas.
